1. Introduction

- 1.1 The Surveillance Task Force (Surv TF) has continued to work based on the previously presented and approved Terms of Reference (ToRs). Additionally, the Surv TF has coordinated to update its action plan to identify key focus areas.
- 1.2 This working paper provides an overview of the items that have been accomplished by the Surv TF, and future work that will be taken on to ensure continued alignment with GREPECAS and ICAO GANP.

2 Discussion

- 2.1 On 24 May 2024, Members of States and Territories of the ICAO NAM/CAR/SAM Regions held a virtual meeting aimed at supporting the review, development, and eventual implementation of an Automatic Dependent Surveillance Broadcast (ADS-B) regulation.
- 2.2 Additionally, the meeting provided an opportunity to highlight the work done by COCESNA and its Member States toward development of a harmonized ADS-B regulation. This work has been identified as a baseline that can be utilized by other ICAO NACC Member States. The meeting was held in a hybrid format to allow for increased participation by those representatives that could not attend the meeting in person. A total of 24 representatives across 11 States/Territories participated in the event.

2.3 As part of the event, the group updated the action plan generating a list of eleven (11) tasks.

 - b) Perform collaborative review of existing and on-going regulatory activities associated with surveillance.
 - c) Kick-off initial discussion on development of an ADS-B analysis tool.
- 2.5 The Surv TF will look to leverage the ADS-B regulatory work done by COCSNA and Central American States to develop a regional template/guideline that can be used to identify key items to be considered as part of the regulatory process.
