Agenda Item 2: Plan Review and update to the NACC/WG AIM TF's Work Programme, Terms of Reference (ToRs).

Under this agenda item, the Meeting will update, review and approve the AIM TF's work programme and ToRs accordingly.

Agenda Item 3: Implementation Status of the AIM Collaborative Plan

Under this agenda item, the Meeting will conduct a follow-up review of valid conclusions and decisions of the GREPECAS/20 Meeting and the NACC/WG/RAP/03 meeting, emphasizing the impact of the latter on the implementation of Aeronautical Information Management (AIM), based on updates due to the set Aviation System Block Upgrade (ASBU), Basic Building Blocks (BBB) and Global Air Navigation Plan (GANP) 7th. Ed., reinforcing the operational and strategic framework of the AIM Partnership Plan. In addition, the AIM implementation status per State and the AIM Tracking Website Dashboard instructions will be explained.

Agenda Item 4: Follow up on the AIM/TF Action Plan and the Collaboration with South American Region (SAM) and Other Task Forces of the NACC/WG
