I wish to confirm that Mexico will host the Tenth Meeting of the North American, Central American and Caribbean Working Group (NACC/WG/10), to be held from 8 to 12 September 2025, in Tulum, Mexico.

The meeting will follow up on NAM/CAR regional aviation planning activities, evaluate the performance of the different regional Task Forces' activities into a single NACC/WG regional work plan, consolidate air navigation innovation activities, discuss the implementation of the Air Navigation Services (ANS) with their respective coordination and planning with the South America Region and reporting to GREPECAS, review and update the operational agreements and update the Group's work plan for the 2025- period 2026. Moreover, the different NACC/WG Task Forces (AIM, AGA, ATM, CNS, MET and E/CAR/CAT/WG) will monitor the implementation progress according to the deliverables, their action plans and the NACC/WG work programme.

The rapporteurs of the different NACC/WG Task Forces and their members (indispensable), as well as managers and heads of Air Navigation Projects of the different NAM/CAR States, as well as air navigation personnel specialized in the different areas of air navigation focused on planning, are invited to participate in the meeting. International Organisations and the industry are also invited.

The meeting will also visit the facilities of the meteorological office in Tulum, kindly organised by the Mexican government.
