EXECUTIVE SUMMARY

This working paper presents recent developments, consolidation efforts, and regional coordination initiatives in Air Traffic Management (ATM) and Air Traffic Flow Management (ATFM) in the NAM/CAR Regions. It highlights the establishment of the Airspace Management and Capacity Balancing Task Force (AMCB/TF), the ongoing alignment of activities with GREPECAS Projects, and regional priorities including Free Route Airspace (FRA), performance-based navigation (PBN), and contingency planning.

The paper also summarizes next steps in the 6-month work plan for AMCB/TF and regional coordination.

1. Introduction

The ICAO NACC Office continues to advance its ATM and ATFM work programs by consolidating efforts and aligning with regional and global frameworks. The recent merger of the Airspace Optimization and ATFM Task Forces into the Airspace Management and Capacity Balancing Task Force (AMCB/TF) reflects a strategic realignment based on efficiency, harmonization, and collaborative regional planning.

2. Background

During the AO/TF/5 and ATFM/TF/7 meetings held in Orlando, Florida, States and stakeholders supported the integration of the task forces to streamline efforts in ATM capacity management and regional coordination. This consolidation supports the implementation of key components of the GANP and aligns with GREPECAS priorities.

3. Key Areas of Progress and Planning

- Finalization of AMCB/TF Terms of Reference and work programme.
- Regional equipment status mapping (data collection from States on current and future CNS/ATM systems).
- Support for FRA and NEOSPACE regional project with SAM Office.
- ATFM harmonization: minimum requirements, cross-border procedures, special events planning (World Cup, Olympics).
- KPI and ASBU alignment with GREPECAS and CADENA initiatives.

4. Next Steps (6-Month Work Plan)

- Collect regional equipment status data and identify gaps.
- Coordinate one virtual meeting and one in-person mission to validate FRA routes.
- Finalize harmonized ATFM framework and KPIs with GREPECAS linkage.
