#### Discussions:

Discuss the ideas for metrics to measure the impact of AIDC implementation

1. Due to time and attendance limitations, this item was not discussed during this teleconference. The discussion was scheduled for the face to face meeting.

Discuss the new goals for the Task Force, specifically setting a goal for Class II/Class III implementation.

- 2. The meeting reviewed the implementations of each State, and considered the possibility of implementing other classes in the near future. The discussion was as follows:
  - a) Cuba: Currently using Class I with some Class II features. The software is not capable of using the full Class II message set. An update is scheduled for 2018 to enable up to Class III capability.
  - b) US-Canada: Currently using Class II in most interfaces. The development for Class III is not scheduled for this year. The engineering for implementation is scheduled for 2017, with implementation possibly 2018. This must be done in sync with Canada.
  - c) Mexico: No date for Class II implementation yet.
  - d) Dominican Republic: with capacity for Class II and III but with some adjustments necessary. Operationally to start with Class I in 2016.
  - e) United States commented that Jamaica is in the process of acquiring an ATC system, which would introduce a new potential interface in the region, but no detail was available at the moment.
- 3. To be able to set a goal, the meeting considered important the participation of the rest of the members, so it will be discussed in the face to face meeting.

Review the working paper to be presented at the ANI/WG/3

4. Working paper 11 for the ANI/WG/3 meeting was reviewed, with no additions or corrections.

#### Other matters

5. United States mentioned that many MOD messages have been sent between their systems and Canada's, and that

6. Mexico indicated that for the visit to the control center, a list of participantes is required. The Rapporteur agreed to obtain the list next week, as it would be more or less definite by that time (ACT 01/14).
