Discussions:

AIDC plan

1. The AIDC plan still needs updating by some States. Action item **ACT 01/09** was created for the Rapporteur to send the AIDC plan to all members for comments, and to update it and sent to ICAO for publishing on the website by June 30.

Comparison of ICDs by Trinidad and Tobago

2. Trinidad and Tobago was to compare the ICDs they may need and report the results. During the discussion, it was determined that the ICD they would need to review is the NAT ICD. ICAO will obtain information on the NAT ICD and the message sets that are being used, by June 20, per ACT 02/09.

Draft of FPL error reporting form

3. The FPL reporting form was reviewed. The only observation was to provide examples of each type of error listed in the form, to provide more clarity in understanding then, action item assigned to Cuba and Costa Rica as ACT 03/09

Upgrades to NAM ICD

4. Regarding the upgrades to the NAM ICD, there is not a specific timeline for the update of the current version, although United States stated that it will be done this year. The three action items, ACT 01/08 through ACT 03/08 regarding the upgrade of the NAM ICD will be condensed into one action item: ACT 04/09: The United States will draft modifications to the NAM ICD, to be reviewed and commented by the task force by the end of July.

Draft of test and implementation guideline document

5. COCESNA indicated that the document was being validated by their personnel, and that they have not experienced an implementation to assure the procedure was correct. It was proposed that COCESNA share the document used by Cuba for the AIDC interchange with the United States as a guideline, accepted and established as action item ACT 05/09.

Three phases of flight plans

6. During the Task Force meeting in April, the subject of the "three phases of flight plans" was brought up. ICAO agreed to investigate the concept for clarification by May 23, but the date was changed to June 20.

FPL Monitoring group

7. The membership of the FPL Monitoring group was presented, organized by FIR. The missing FIRs of the list were completed during the teleconference, except for Curaçao. ICAO agreed to contact Curaçao to propose their representative for the FPL Monitoring group as ACT 06/09.

E/CAR centralized flight planning system

- 8. Trinidad and Tobago informed that the centralized flight planning system that will serve the E/CAR region is estimated to be implemented by December of this year, responding to action item ACT 09/08.

Action item 07/09 was created for the Rapporteur to send these terms of reference to the Task Force as information. Also, action item 08/09 was created for the Rapporteur

to send the draft State Letter from ICAO for the FPL monitoring group.
