2.0 INTRODUCTION OF GROUP MEMBERS

- 2.1 The meeting began at approximately 1510 UTC as time was allowed for more participants to join in and was conducted in English.
- 2.2 ICAO provided an overall briefing on the NAM/CAR Air Navigation Implementation Working Group (ANI/WG) and the creation of the PBN Taskforce, with Riaaz elected as PBN TF rapporteur. Group members were given an opportunity to speak about themselves and the rapporteur advised that his role was really the coordinator of the group and requested participation (comments, suggestions etc.) from all members.
- 2.3 Alexi Batista will replace Jose Perez from Dominican Republic as informed by Dominican Republic.
- 2.4 ICAO invited all TF participants to take advantage of the good composition of this TF, where IATA and IFATCA are also members, which can support the TF with the users' perspective and assistance.

3.0 BRIEF DISCUSSION ON TERMS OF REFERENCE (TOR)

- 3.1 ICAO explained the role of the taskforce and suggested that the group look at work currently being done by the sub regions (E.g. ECAR/CATG) in developing its work programme. He also advised that issues within the region that required immediate attention should be prioritized in the task list as for ex: ATS route agreements, procedure design needs, etc.
- 3.2 The deadline for submission of the work programme is the end of October.
- 3.3 <u>ACT01:</u> The rapporteur asked the group to begin sending suggestions for the work programme as soon as possible and gave a deadline for these submissions as **September 20th 2013.** <u>ACT 02</u>: The rapporteur informed that by **17 September,** he would send out previous work plans of other groups as samples as well as the RPO's for PBN Implementation.
- 3.4 The rapporteur also informed the group that while the work programme is being developed, work can also take place. An example of this as outlined by Julio was the requirement for Jamaica to enter into discussions with neighbours in the SAM region (Colombia and Panama), for which the PBN TF can assist

in the proposal and the ICAO NACC Regional Office, will assist also in coordinating it with the SAM Region. The NAM/CAR PBN Taskforce can work among itself within the region, but must coordinate through the NACC Regional Office when discussion is required with other regions, (e.g. SAM region). **ACT 03**: Jamaica will continue this task and communicate its proposal by **27 Sept 2013**.

3.5 <u>ACT 04</u>: A draft work programme will be presented by the Rapporteur by the **26th September**, **2013** (Next teleconference).
