Subject: **First Meeting of Civil Aviation Training Centres in the NAM/CAR Regions (NAM/CAR/CATC/1) – Invitation**
ICAO NACC Regional Office, Mexico City, Mexico, 27 to 30 August 2013

Sir/Madam:

I refer to the Fourth Meeting of Directors of Civil Aviation of North America, Central America and Caribbean (NACC/DCA/4) held in San Pedro Sula, Honduras, from 20 to 24 June 2011, and in particular item g) of Conclusion 4/8 – *Civil Aviation Training in the CAR Region*, which stated: “the ICAO NACC Regional Office convene a CAR Region Civil Aviation Training Centres meeting during the first quarter in 2012.”

As you know, this meeting was replaced by invitation and participation of CAR Region States/Territories at the Twelfth Meeting of Directors of Civil Aviation Training Centers (CIAC/12), which was held in 2012 at the ICAO SAM Regional Office in Lima, Peru. Nevertheless, the CAR Region State representatives who attended the Fifth Regional Symposium on the Next Generation of Aviation Professionals (NGAP) and TRAINAIR PLUS -- The Americas held in Montego Bay, Jamaica, from 5 to 7 February 2013, requested ICAO to convene a CAR Region civil aviation training centres meeting during 2013.

As a result of this request, I have the honour to invite your Administration to participate in the First Meeting of Civil Aviation Training Centres in the NAM/CAR Regions (NAM/CAR/CATC/1) to be convened at the ICAO NACC Regional Office, Mexico City, Mexico, from 27 to 30 August 2013. The working languages of the meeting will be English and Spanish, and simultaneous interpretation will be provided if sufficient participants of both languages provide timely registration.

Directors of regional and national Civil Aviation Training Centres of States and Territories of the ICAO CAR Region are expected to attend. The purpose of this meeting will be to review the progress achieved with training and human resources planning and development through the Next Generation Aviation Professionals (NGAP) Task Force and TRAINAIR Plus Programme.

The Provisional Agenda of the meeting is at **Attachment A**. States wishing to submit proposals for additional items should do so by **3 June 2013**. You are also requested to complete the Registration Form at **Attachment B** in Microsoft Word for each participant and forward by e-mail to this office by **26 July 2013**.

Taking into consideration the availability of documentation in electronic format, no hard copies will be distributed during the event, and it is recommended that participants bring a laptop or tablet to the meeting.

Documentation that your Administration may wish to submit/present at the meeting should be forwarded to this office by e-mail as soon as practicable in Microsoft Word format using the attached templates (**Attachment C**). Working papers should be brief, action-oriented, and focused with a four-page limit excluding any appendices.

Only working papers **received** by this office by **12 July 2013**, submitted by States/Territories, will be translated to ensure timely processing. Working papers received in this office **after** that date will have to be sent **in both languages**. Information papers will only be issued in the language of submission. Papers received from international organizations will not be translated and will be issued only in the language submitted. The deadline to receive papers is **12 August 2013**. The deadlines for submission of documentation for translation will be strictly enforced. You are encouraged to submit documentation in both meeting languages, i.e., English and Spanish.
