1 OBJECTIVE

- 1.1.1 This Contingency Plan contains arrangements to ensure the continued safety of air navigation in the event of total disruption of air traffic services (ATS) within the Turks & Caicos and is related to ICAO Annex 11 Air Traffic Services Chapter 2, paragraph 2.29.
- 1.1.2 The Contingency Plan shall provide alternate arrangement for essential authorized flights into and out of aerodromes within the Turks & Caicos.
- 1.1.3 The Contingency Plan applies to the following Aerodromes and ATS Services within the Turks & Caicos Islands.
- a. Providenciales Approach and Aerodrome Control Unit
- b. Grand Turk Aerodrome Control Service
- c. South Caicos Flight Information Service
- d. North Caicos Flight Information Service

2 AIR TRAFFIC MANAGEMENT

- 2.1 Air Traffic Services Responsibilities
- 2.1.1. In the event that ATS cannot be provided within the Turks & Caicos, the ATS unit shall publish the corresponding NOTAM indicating the following. Should the ATS units be unable to communicate the NOTAM, MIA ARTCC shall do so including as much of the available elements of information below:
- a. Time and Date of the beginning of the Contingency Measures;
- b. Airspace condition of use.
- c. Air Routes available for arriving and departing;
- Details of the facilities and services available or not available including an expected date/time of restoration of services if available;
- d. Information on the provisions made for alternate services;
- h. Any other details with respect to the disruption and actions being taken that aircraft operators may find useful.

2.2. Affected FIRs:

- 2.2.1. The following FIR is directly affected by the present contingency plan:
- Miami ARTCC
- 2.3 Separation
- 2.3.1 As applied by MIA ARTCC
- 2.4. Level Restrictions
- 2.4.1. As applied by MIA ARTCC
- 2 Turks & Caicos Islands ATS Contingency Plan

2.5. Other Measures

- 2.5.1. Other measures related to the unavailability of ATS and the implementation of this Contingency Plan within the Turks & Caicos may be taken as follows:
- Suspension of all VFR Operations (NB: VFR flights shall not be operated in the Turks and Caicos island CTR if there are extensive disruptions to ATC facilities, except in special cases such as State aircraft, Medevac flights, and any other essential flights authorized by the Turks & Caicos Island Civil Aviation Authority).
- Delay or suspension of General Aviation IFR Operations; and
- Delay or suspension of commercial IFR Operations.
- Suspension of all Flight Operations.

3. TRANSITION TO CONTINGENCY PLAN

- 3.1.1 In the event that the unavailability of ATS has not been promulgated, Miami ARTCC shall broadcast to all aircraft destined to international Airports in the Turks & Caicos, that ATS are not available and to stand by for any further instructions.
- 3:1/2 MIA ARTCC will be endeavor to contact ATS personnel in the Turks & Caicos as per the contact list (attachment 2). Failing contact with ATS personnel in the Turks & Caicos will divert all flights to their alternate airports.

4. PILOTS AND OPERATOR PROCEDURES

- 4.1 Pilot shall:
- a) maintain last assigned altitude, heading and clearance limit and make contact with MIA ARTCC for further or alternate clearance.
- b) keep the last SSR transponder assigned. If no transponder assigned, select 2000 code.

5. CONTINGENCY UNIT

- 5.1. By delegation of the Turks and Caicos Islands Airports Authority, the responsibility of monitoring developments that may dictate the activation of the Contingency Plan and coordination of contingency arrangements is assigned to:
- Miami ARTCC
- Operations Manager
- 5.1.2 MIA ARTCC will liaise with the ICAO Regional Office.
- 5.1.3 The ICAO Regional Office will:
- a. closely monitor the situation and coordinate with all concerned affected States and the IATA Regional Office;
- b. take note of any incidents reported and take appropriate actions;
- c. provide assistance as required on any issue with the FAA; and
- d. keep the President of the Council of ICAO, the Secretary General, the Chief Regional Affairs
 Officer, the Director of the Air Navigation Bureau and the Chief of the Air Traffic Management Section
 continuously informed on developments, including activation of the Contingency Plan.
