I wish to invite representatives from your Organization to the 2024 ICAO NAM/CAR/SAM Environmental Regional Seminar, to be held at Asunción – Paraguay, from 20 to 21, August 2024, as an in-person event.

In the 41st Session of the ICAO Assembly held in 2022 the collective long-term global aspirational goal (LTAG) for international aviation of net-zero carbon emissions by 2050 was adopted, and the Third Conference on Aviation and Alternative Fuels (CAAF/3) adopted the ICAO Global Framework on Sustainable Aviation Fuels (SAF), Lower Carbon Aviation Fuels (LCAF) and other aviation cleaner energies in 2023.

In this regard, ICAO is organizing five Environmental Seminars in different regions. The aim of these Seminars is to raise awareness and exchange views on the implementation of the LTAG and Global Framework, including recent developments on cleaner aviation energy policies and State Action Plans, CORSIA as the basis for the eligibility of aviation cleaner energies, implementation challenges and the ICAO Assistance, Capacity-building and Training for Sustainable Aviation Fuels (ACT-SAF), and financing cleaner aviation energies, as well as the means for monitoring the progress for the implementation of the LTAG and Global Framework.

Health Requirements for Entry to Paraguay

Yellow fever vaccine. (Mandatory for travelers coming from risk areas Brazil, Bolivia, Peru and Venezuela) and recommended by travelers coming from other countries. Through Resolution SG No. 040/2022, the Ministry of Health establishes that all travelers, national or foreign, coming from risk areas: Brazil, Bolivia, Peru and Venezuela, must be vaccinated against Yellow Fever and have the International Certificate of Vaccination that accredits it.

The presentation of the International Certificate of Vaccination against Yellow Fever may be required by the personnel of the transport company at the time of purchasing the ticket or by officials of the surveillance area of the Ministry of Health before carrying out the immigration procedures.

People who, for health-related reasons, cannot receive the vaccination, must justify their situation through a certificate issued by a medical professional registered and authorized by the Ministry of Public Health or by the health authority of the country of origin and comply with the health monitoring and control for a period of ten days from their admission.

COVID vaccine.

As of October 24, 2022, the protocol for entry into the country of 02/06/22 is null and void, so the presentation of the COVID-19 vaccination card or the RT-PCR test for entry into Paraguay is no longer required. Participants must be in good health and have metered insurance or other health coverage to deal with cases of illness or medical emergency that may arise, as neither ICAO nor the DINAC of the Paraguayan Government are responsible for possible medical expenses incurred by a participant.

18. Places of interest to visit in the city of Asunción and the metropolitan area

Asunción is the capital and most populous city of the Republic of Paraguay. It is an autonomous municipality administered as a capital district and is not formally integrated into any department. It is located in the center-west of the Eastern Region of the country, bordered to the north by the Paraguay River that separates it from the department of Presidente Hayes, and in turn from the Western Region; to the south and east by the Central Department and to the west by the Paraguay River, near the Pilcomayo River, which separates it from the Argentina. Founded on August 15, 1537, it is one of the oldest cities in South America.

Asunción, Paraguay, August 20-21, 2024.

With 521,091 inhabitants in 2023, it is the most populous and urban city in the country. Meanwhile, its metropolitan region, called Greater Asunción, increases its population to almost 2,343,908 inhabitants, thus making it one of the 20 largest urban agglomerations in South America. Its area is 117 km² in the city, and 2,582 km² in Greater Asunción.

Asunción is the seat of the three branches of government (Executive, Legislative and Judicial), and the main river port (General Directorate of Customs), and is also the cultural center of the country. Despite some variations in the course of time, from its foundation to the present day, Asunción is the center of national activity. From the capital, the main resolutions and projects of the powers of the State are issued, and the banking, economic, cultural, diplomatic, social, trade union and industrial entities of the country are centralized. From Asunción they teach most of the main routes of the country, to the main cities of the country.

Asunción is considered a global city of "gamma-" category. The city ranks among the cheapest capitals in the world, and lately as one of the best cities for investment, both in construction and services. It also has a variety of gastronomy, hotels and first-class shops, preserving to this day most of its historic buildings, combined with wide and tree-lined avenues that have the largest infrastructure of shopping centres, bars, cinemas, casinos, theatres and entertainment venues within the city. It is recommended to bring sunscreen, hats, comfortable shoes such as sandals, sports shoes (tennis), cool clothes and mosquito repellent.
