SUMMARY

The LACAC-ICAO AVSEC/FAL Regional Group is requested to prepare the working and/or information papers to be submitted at the 38th Session of the ICAO Assembly, taking into account the topics proposed in the Draft "Guide" approved by the LACAC Executive Committee.

1. INTRODUCTION

- 1.1 The LXXXII Meeting of the Executive Committee of the Latin American Civil Aviation Commission (Guayaquil, Ecuador, August 2012) was informed of the convening of the 38th Session of the ICAO Assembly (Montreal, Canada, from 24 September to 4 October 2013). The LACAC Secretariat took this into account when developing the draft "Guide" format for its participation in that event. In this regard, the Executive Committee approved the draft Guide format so that the LACAC Secretariat and Panels (GEPEJTA and AVSEC/FAL) could prepare the corresponding working or information papers.
- 1.2 For the participation of LACAC member States at the ICAO Assembly, there are "Guidelines on procedures for LACAC Coordination Meetings at ICAO World Conferences", a copy of which is attached to this paper (**Appendix 1**) for the knowledge of State experts.

- 1.3 At the thirtieth meeting of the LACAC Panel (GEPEJTA/30, Lima, Peru, January 2013), Colombia, as focal point for macro-task "Transport and Air Policy", and after coordinating with the Secretariat, submitted a working paper (LACAC/GEPEJTA/30-WP/10) containing the Draft LACAC Guide for the 38th Session of the ICAO Assembly.
- 1.4 Following the corresponding debate, GEPEJTA agreed to create an *ad-hoc* group (Argentina, Brazil, Colombia (speaker), Peru, Dominican Republic, Uruguay, ALTA and the Secretariat), to draft working papers that would reflect the common interests of the LACAC member States, in order to present a harmonious and organised regional position at the 38th Session of the ICAO Assembly.
- 1.5 The aforementioned *ad-hoc* group met in Bogota, Colombia, (2-3 May 2013), where it reviewed the draft papers to be submitted and the position to be adopted on some items of the Agenda for the Assembly. The attached **Appendix 2** contains the draft "Guide" being developed.

2. DISCUSSION

2.1. As may be noted in the Draft Guide, it has been deemed advisable for the AVSEC/FAL Regional Group to draft working and/or information papers on Agenda Items 13, 14, 15 and 16 of the 38th ICAO Assembly, taking into account the work being done since the beginning of its activities and the proposals to be submitted at the aforementioned meeting.

3. SUGGESTED ACTION

3.1 The Meeting is invited to create an *ad-hoc* group to prepare the working and/or information papers to be submitted at the 38th Session of the ICAO Assembly, and/or suggest regional positions on issues it may deem relevant.

APPENDIX A

GUIDELINE ON PROCEDURES FOR LACAC "COORDINATION MEETINGS" AT ICAO ASSEMBLIES AND/OR WORLD CONFERENCES

INTRODUCTION

1. Civil Aviation Authorities of LACAC member States hold coordination meetings before and during the main global meetings summoned by ICAO, *i.e.*, Assemblies and World Conferences. Taking into account the work experience gained in the last few years and the need to establish some guidelines to optimise coordination and harmonisation of positions, the Executive Committee has deemed it advisable to issue the following Guideline on Procedures:

LEGAL FRAMEWORK

2. In accordance with Articles 15 and 39 of LACAC By-laws and Internal Meeting Regulations, respectively, the Executive Committee must manage, coordinate and direct the work programme established by the Assembly, and can create Committees and Working Groups or Panels as needed.

PURPOSE

3. The purpose of coordination meetings is for the Authorities of LACAC member States to discuss and agree on matters of common interest in order to present a harmonious and organised regional position at ICAO World Conferences.

PARTICIPANTS

- 4. The delegates of member States, observer States and organisations, and special guests may participate at the "coordination meetings", the latter when so agreed by the Executive Committee or the participants of the "coordination meeting" themselves.
- 5. Participants shall bear in mind that this type of meetings does not imply any official representation and that they basically seek the harmonisation of positions and the establishment of strategies to attain regional objectives.
- 6. "Coordination meetings" shall be public; although, when so agreed by the representatives of member States and the item to be discussed so requires, they may be held behind closed doors.

CONVENING

7. After the respective approval by the Executive Committee, "coordination meetings" will be convened by the Secretariat, taking into account the LACAC work programme, the issues to be addressed, and the agreements reached within the Organization at preparatory events or meetings. The Secretariat will also prepare a tentative Agenda, the relevant documentation, and will make all the necessary arrangements to set the venue and the dates for the "coordination meeting".

STEERING GROUP

- 8. <u>Coordination</u>: The highest authority of the State that holds the chair of LACAC at that time will act as Coordinator at the "coordination meetings"; in his/her absence, the designation will fall upon the highest authority of the States holding the vice-chairs of the regional Organization, in order of precedence.
- 9. <u>Secretariat</u>: The Secretary of LACAC will act as secretary of the "coordination meetings".

WORK METODOLOGY

- 10. In order to review the instructions that the Executive Committee may have issued and the documents prepared by the Secretariat, work sessions will start at least one day before the Conference convened by ICAO, and as many sessions as necessary will be held throughout the duration of the event.
- 11. Both the participants and the Secretariat may submit work documents, in accordance with the Agenda.
- 12. Formalisms will be avoided at the meetings, encouraging freedom of speech in order to achieve the proposed objectives.
- 13. Commonly agreed proposals formulated by the participants at the "coordination meetings" shall reflect the regional criterion and will be presented at the ICAO Conferences by the Coordinator or the State selected for that purpose.
- 14. Taking into account that contacts are normally established at this type of meetings to agree on positions with other States, regional organisations or groups of States, the Coordinator will submit to the consideration of the participants the strategy to be applied in each case.
- 15. In the case of political contacts, the Coordinator, with the support of the representatives of the States he/she deems appropriate, will be the spokesperson for the regional position as previously agreed at the "coordination meeting".
- 16. In the case of participating in special or working groups created during the ICAO World Conference, the Coordinator, considering the best representation for the Region, will select from the participants those who will act as "focal points" in said groups.
- 17. The so-called "focal points" will be responsible for conveying the regional criteria to these fora and informing the "coordination meeting" as a whole about the agreements reached and other matters concerning said groups.

THE REPORT

18. Upon completion of each "coordination meeting", the Secretariat will prepare a report containing a brief summary of the work done and the main agreements reached, which will be submitted to the Executive Committee at its next meeting.
