### 1. Introduction

- The First Meeting of the GREPECAS Programmes and Projects Review Committee 1.1 (PPRC/1) was held in Mexico City, Mexico, from 25 to 27April 2012.
- 1.2 The Secretariat presented the proposed content for the GREPECAS Annual Report, which was prepared with reference to the GREPECAS Terms of Reference and Work Programme, GREPECAS meeting reports, comments of the ANC on the GREPECAS/16 report, PIRG reports from other regions, and in consultation with the ICAO Air Navigation Bureau.

- 1.3 Taking into consideration the results of the GREPECAS/16 meeting and associated comments of the ANC, the future GREPECAS Annual Reports will have the following objectives:
  - a) provide annual GREPECAS reports in between the triennial GREPECAS meetings;
  - b) inform on GREPECAS activities, progress and results of its programmes and projects;
  - c) inform on the GREPECAS PPRC meeting results;
  - d) seek guidance and approval from the ANC as applicable and when required; and
  - e) provide the web references to relevant supporting documents.
- 1.4 If not having a triennial meeting of GREPECAS, the Secretariat will prepare future GREPECAS Annual Reports based on the results of PPRC meetings, complemented with information on other relevant regional developments and results, circulated to GREPECAS member States for review, comment and approval, and then submitted to the Air Navigation Bureau for presentation to the ANC.
- 1.5 The Meeting also noted that the ANC had decided that in the future it will review a single consolidated report for all PIRGs every year.
- 1.6 The PPRC/1 Meeting agreed on the proposed content for the future GREPECAS Annual Reports in Decision 1/4.

# 2. **Analysis**

- 2.1 However, ANB and the ANC are seeking to simplify and standardize the format PIRG reports, as well as consolidate the timing for the review of all the PIRG reports. For this reason, it is proposed to revisit the existing GREPECAS approved of PPRC Decision 1/4 regarding the GREPECAS Annual Report content.
- 2.2 Furthermore, the planned future regional and global reporting will have a cyclic linkage between Global Plans, Regional Performance Dashboards and Global Annual Reports for both Safety and Air Navigation (**Appendix A**). The regional dashboards are scheduled to be online by March 2014. An initial set of metrics for Safety and Air Navigation was agreed during the PIRG-RASG coordination meeting (Ref. WP/05). Consequent to this new reporting structure to be implemented in 2014, the ANC and Council will no longer review individual PIRG/RASG reports unless a specific action is called for. In this respect the following Draft Decision is presented:

# **Decision PPRC/2-X** New GREPECAS Annual Report

That, GREPECAS submit an annual report to ANB consisting of the GREPECAS meeting report in years when a GREPECAS meeting is held, and a PPRC meeting report in other years, which includes a table of Conclusions and Decisions in the format presented in Appendix B.

- 3.1 That the CRPP:
  - a) take note of the information of this working paper; and
  - b) analyze for its approval the draft decision presented in section 2.
