# MRTD Programme

- Aimed at producing standardized and interoperable specifications for issuance and verification of travel documents
- Build confidence in the reliability of travel documents
- Effective inspection procedures
- Facilitating inspection formalities for the majority of travellers
- Last but not least: aiming at enhancing both security and facilitation

# The Chicago Convention 1944

The main international legal instrument re: civil aviation  
and ICAO's role

- ✿ Provisions include requirements:

- Art 13: persons travelling by air and crews to comply with immigration, customs and passport regulations
- Art 22 & 23: States to facilitate border clearance formalities and prevent unnecessary delays – and to collaborate on these matters
- Art 37 (j): States to develop and adopt int'l standard procedures for immigration and customs clearance

- ✿ Creates ICAO's mandate and responsibilities regarding Standards and Specifications for MRTDs and eMRTDs

# The Chicago Convention 1944

- Annex 9 – Facilitation
  - CHAPTER 1. General Principles
    - Information exchange and sharing
    - Develop effective information technology – increase efficiency
    - Develop procedures for pre-arrival lodgement of data - expedite
  - CHAPTER 3. Entry and departure of persons and their baggage
    - Documents required for travel
    - Security of travel documents
    - Travel documents – Doc 9303
    - Inspection of travel documents
    - Entry procedures – Transmission of data – API and PNR

# ICAO 37<sup>th</sup> Assembly Resolution A36-15

- Requests the Council to ensure that its specifications and guidance material in Doc 9303 remain up to date in the light of technological advances and to continue to explore technological solutions aimed at improving clearance procedures
- Urges States to intensify their efforts to safeguard the security and integrity of the breeder documentation
- Requests the Council to take appropriate measures to establish guidance on breeder documentation



# ICAO 37<sup>th</sup> Assembly Resolution A36-15 contd.

- Urges States to intensify their efforts to safeguard the security and integrity of their passports, to protect their passports against passport fraud, and to assist one another in these matters
- Urges States requiring assistance in implementing MRTD standards and specifications to contact ICAO without delay
- Requests the Council to continue working on enhancing the effectiveness of controls on passport fraud and developing guidance material to assist States in maintaining the security and integrity of their passports and other travel documents


# ICAO 37<sup>th</sup> Assembly Resolution A36-15 contd.

- Urges all States issuing ePassports to join the ICAO PKD; and all receiving States to verify the digital signatures
- Urges all States to provide routine and timely submissions of lost and stolen passport data to Interpol's SLTD database
- Urges States, in their use of electronic data sharing systems, to ensure that their passenger data requirements conform to international standards adopted by UN agencies


# ICAO MRTD Programme at a glance




# ICAO MRTD Programme Strategic Review

- Setting agenda for the future – formulating a new ICAO MRTD Strategy
- Reasons: how to enhance the relevance and benefits to States, our primary constituents
- Focus on enhancing both security and facilitation benefits
- A consultative process involving MRTD and border security stakeholders (States and their agencies, industry, the aviation community, experts, think tanks, the public, etc.)

## MRTD Programme Strategic Review – CONTD.

- Initiated by the Chairs of TAG/MRTD and working groups in early 2011
- Draft Strategy expected by the end of 2011
- To link strategic MRTD objectives, resources, implementation modalities, institutional arrangements and performance management
- Further momentum – the High-Level ICAO Conference on Security (incl. exploring the role of travel documents, data sharing and border security in the broader context of a comprehensive aviation security vision)

# Key considerations in developing a new ICAO MRTD Strategy

- How to make it relevant to the needs and expectations of stakeholders
  - In practical terms – how to maximize security and facilitation benefits to respond to current and tomorrow's challenges
  - Two key aspects under consideration:
    - Broadening, and
    - Deepening
- of the MRTD programme
- These considerations not “official” yet but part of the working and development process

# Why considering broadening?

- Strengths
- Mandatory standards
- Solid and comprehensive specifications how to manufacture and personalise MRTDs
- Sustainable mechanism to maintain Doc 9303 current and integrate new technologies – TAG/MRTD NTWG
- Challenges
- Criminal focus shifting to lesser developed areas:
- Evidence of Identity
- Issuance process
- Travel document fraud
- Identity fraud at the border
- Unless addressed, weakens the core MRTD programme!

# Broadening the MRTD Programme

## Scope: 3 pillars

### Evidence of Identity issues

- Breeder documents
- Civil registries
- Integrity of the issuance process
- Preventing irregularities in issuance

### Manufacturing and personalisation of MRTDs and eMRTDs

### Border control issues

- Document inspection at the borders
- Combating travel document fraud
- Data sharing
- New technologies for border controls and border security

# Deepening the MRTD Programme

Main directions being considered:

- Developing new SARPs related to MRTDs and border controls
- Providing assistance to States and capacity-building (ICBWG and ICAO TCB)
- Vocational training under development:
  - Management of TD issuance processes
  - Travel document security verification
  - ICAO PKD

## WHAT ELSE DO WE DO

# Implementation of MRTDs depends on:

- Access to the necessary expertise
- Access to adequate, necessary and functional equipment for edition, organization and implementation of MRTDs
- Capacity of manpower of States to operate equipment, training and maintain this capacity
- Management of the stakeholders and the process-associated risks

# ICAO Assistance and Technical Cooperation

- Mobilize resources
- For a single country or a sub-region
- ICAO and requiring State assess the needs
- Identification of experts, trainers
- Identification of suitable donors

- Compliance with Annex 9 and Doc 9303
