
#### Introduction

❖The USOAP results and findings include Lack of Effective Implementations directly related to training. 29 states have EI less than the average 52%.

Lack of effective implementation of the safety target in Africa is a serious concern and ICAO is taking every action to help states reach the minimum safety targets.

#### Introduction

- The role of training is recognized to be crucial to reach the safety targets and thus endow states with necessary tools to build solid HR capacity to sustain the industry growth.
- ❖ Recommendations 5/8 of the special African and Indian Ocean Regional Air Navigation Plan (AFI- RAN) meeting held in Durban in South Africa in 2008.



## Training Standardization

- States do not have sufficient means to devote to the training of personnel in technical, management and leadership disciplines.
- Unavailability of reliable data on ATOs and courses.
- Lack of coordination and cooperation among ATOs and states.

#### **AATO Role**

- AATO has developed a framework for the establishment of centers of excellencies.
- Ensure standardization of training programs, instructor qualifications.
- Approve aviation training organizations and eventually publish reports on the status of aviation training needs and resources.

- Access to a network of approved Africa.
- Access to cost effective training and facilities.
- Better visibility for your training organisation.
- Common acceptance and recognition of training and certificates.



- Pooling of instructors, course material and training facilities.
- Access to standardized curriculum and training content.
- Support and guidelines towards being designated as a centre of excellence.
- Representation on regional and international fora.



- Research and Consultancy services towards training model improvements.
- Increase capacity to commercially benefit from an increased demand of aviation training.
- Access to current market information reflecting accurate supply, demand and capacity in Africa.



- Standardization and harmonization of aviation training must be addressed jointly by AATO,GAT and all stakeholders.
- Sustainable air transport is possible if and only if there are adequate and competent professionals with quality training.
