1. BRIEF REVIEW OF WORK DONE ON WEDNESDAY, 26 NOVEMBER 2008

- 1.1 The Efficiency Committee met at 0930 hours as a working group of the whole and held its second meeting and completed its discussions on WPs 12, Rev. No. 1, 53 and 73 and also reviewed WPs 8, 18, 20, 21, 39, 40, 46, 51, 54, Corr No. 1, 55, 56, 57, 58, 59, 67, 68 and 74. The Efficiency Committee is slightly ahead of schedule and should complete its work by lunch time on Thursday.
- 1.2 The Safety Committee met at 0930 hours as a working group of the whole and reviewed WPs 16, Revision No. 1, 61, 62, 64, 50, 48, 49, 30, 38, 45, 28, 77 and 35 on Agenda Item 5 Development of a set of comprehensive work programmes in the safety field. The meeting agreed that timeframes should be established in the region to meet the objectives of the Global Aviation Safety Plan (GASP). These objectives would be considered preliminary until findings were available from the GAP analysis presently underway in the region. This approach would allow for the establishment of realistic timeframes to comply with the GASP process.

- 2.2 The Safety Committee will meet as a working group of the whole and review WPs 32, 27, 31, 75 and 9. The Committee will, as a working group of the whole, continue its discussions on Agenda Item 5 Development of a set of comprehensive work programmes in the safety field.
