1. Introduction

- 1.1 The sixth meeting of the AFPP Steering Committee has approved a work programme for the period of 2020-2021 focussed on projects implementation and capacity building through workshops and trainings.
- 1.2 This working paper provides the status of the implementation of the work programme activities and a revised planning for their completion as an appendix to this paper.

2. DISCUSSION

- 2.1 As detailed in working paper 2.1 (Membership and PBN implementation status), due to constraints mainly related to Covid-19, some of the training were not held and 90% of flight procedure design project have not been completed.
- 2.2 Behind all procedure design projects, there are financial commitments. Adequate solutions should therefore be found to implement at least 60% of the remaining activities. The rest of the non-completed projects as well as the remaining training activity can be postponed to Phase III if agreed. In this regard, this current paper provides a revised planning for the remaining activities for consideration by the meeting.
