#### 1. Introduction

- 1.1 The ultimate goal of the AFPP is to assist African States in implementing ICAO Assembly Resolution A37-11 on Performance-based Navigation. Working paper 2.1 presented the PBN implementation status since the inception of the Programme while working paper 3.1 provided a revised planning for the remaining Phase II activities.
- 1.2 This working paper provides proposals for the conduct of Phase III of the Programme.

#### 2. DISCUSSION

- 2.1 As presented in working paper 2.1 (Membership and PBN implementation status), despite the efforts made by the Programme, the PBN implementation ratio is still low at the continent level. The Continuous Climb and Descent Operations (CCO/CDO) are one of the key elements of the ASBU framework with regard to PBN and were not included in the previous strategic objectives. Consequently, they have to be accounted for in Phase III.
- 2.2 With regards to Phase II, even with the agreed extension, some of the approved activities cannot be completed. As detailed in working paper 2.1, the set objectives for the Programme are not yet met.
- 2.3 As a response to the above-mentioned challenges, the following revised strategic objectives and Phase II to Phase III transition action plan are provided in the Appendix and therefore submitted for the consideration by the Steering Committee.

  - a. Take note of the information provided in this paper,
  - b. Approve the conduct of Phase III and its strategic objectives;
  - c. Decide on the recruitment of the AFPP Manager; and
