1. **INTRODUCTION**

- 1.1 The Tenth meeting of the AFPP Steering Committee held from 19 to 21 November 2025 in Dakar, Senegal, took decision SC/10-Dec07 approving the continuation of the Programme through the conduct of a Phase IV.
- 1.2 To this end, a Task Force was established with the goal to formulate recommendations to the Steering Committee to enable the implementation of Phase IV. The Task force was composed of Angola, Cameroon, Côte d'Ivoire, Senegal, Tanzania, Uganda, Zambia and ICAO as Secretary of the meeting.
- 1.3 Following the presentation of this report, the meeting has taken appropriate decisions. Based on these decisions, the Programme document must be revised.
- 1.4 This working paper presents the revised Programme document taking into account these decisions.

2. **DISCUSSION**

- 2.1 The meeting has followed the recommendations of the Task Force and has taken important decisions that shall be captured in the new programme document. The main changes relate to:
 - a) Project objective, deliverables and activities (Section 2);

- b) Project members (§ 3.2.2;
- c) Project Budget (Appendix A).
- 2.2 The revised Project objectives, deliverables and activities will be revised as presented in the Programme document (Attachment 6.2-ATT A).
- 2.3 As the meeting agreed to remunerate the experts, they will be recruited as consultants during Phase IV. The Project personnel is revised as follows:
