The objective of this working paper is to review the list of the members with voting rights who are attending the current meeting and decide on the validity of the meeting.

Deliberations of the Steering Committee meetings

1. **INTRODUCTION**

- 1.1 According to the Programme document, the Steering Committee shall meet at least once a year, normally in the country of its current Chairperson or Vice-Chairperson or elsewhere if not possible for the meeting to be held in the country of the Steering Committee's current Chairpersons.
- 1.2 Its roles and responsibilities are among others to formulate priorities, provide overall direction to the Programme, approve the work plan, the budget, the reports and assess the Programme performances.
- 1.3 The Steering Committee meeting is conducted in English and is chaired by the Chairperson and the Vice-Chairperson. The Steering Committee decisions are valid only if a quorum of at least one third of the Steering Committee members with voting rights is reached.
- 1.4 The objective of this working paper is to review the list of the Programme members with voting rights attending the current meeting and decide on its validity.



2. **DISCUSSION**

- As per the provisions of Appendix D of the Programme document (Steering Committee Rules), the Steering Committee is composed of the Project Members, i.e. of the signatories of the Management Service Agreement (MSA) for the African Flight Procedure Programme (AFPP) between ICAO and the Members of the AFPP.
- 2.2 The types of membership, the commitments and the corresponding number of votes are detailed in the table below.

- 2.3 Moreover, Steering Committee Decisions SC/7-Dec14 and SC/8-Dec03 requested to demote Active Members in arrears with the annual financial contributions for more than three years to Users of the Programme, i.e. they lose their voting rights and free access to the trainings and workshops.
- As shown in attachment 1.1 below, the Programme currently encompasses thirty-seven members States including thirty-three active members and four users. Taking into account the host administration, the donors, the cooperating agency and the implementing agencies (4), the total of members with voting rights is 41. This number is compared with the participants of the present meeting in the table below.

- As shown in the table above, the 22 out of the 42 voting members (52.3% per cent) are present. As the required minimum participation for the conduct of a Steering Committee meeting is one third (33 per cent), therefore the quorum is established.
- 2.6 The meeting should take note that the ICAO EUR/NAT is a member of the Programme with voting right but never participate in the steering committee meeting. This can affect negatively the quorum.

3. **ACTION BY THE MEETING**

- 3.1 The Steering Committee is invited to:
 - a) Take note of the information provided in this working paper;
 - b) Decide on the voting rights of the ICAO EUR/NAT; and
 - c) Proceed with the conduct of the SC/10 meeting.
