# TERMS OF REFERENCE, WORK PROGRAMME AND COMPOSITION OF THE SAT ATM WORKING GROUP (ATM/WG)

- Considering the evolutionary implementation of CNS/ATM systems in areas of routing AR1/HA1 and AR2/HA8 as defined in the Global Air Navigation Plan (ICAO Doc 9750), the Task Force should explore ways and means to achieve further enhancements in ATM capacity and aeronautical telecommunications, and to implement CNS/ATM elements taking into consideration the timescales agreed for these areas of routing. It will be guided by the requirements identified in the AFI and CAR/SAM CNS/ATM Implementation Plans.
- Note: The Task Force will adopt a pragmatic approach and may set up auxiliary bodies to carry out specific tasks, as necessary.

- Considering the CAR/.SAM and AFI Air Navigation Plans, the SAT CNS/WG should explore
  ways and means of achieving further enhancements in ATM efficiency within in areas of routing
  AR1/HA1 AR-2/HA8 as defined in the Global Air Navigation Plan (ICAO Doc 9750), by resorting
  to emerging technologies and, in particular, by taking advantage of rationalization, integration and
  harmonization of systems where appropriate.
- Implementation of new systems should be sufficiently flexible to accommodate existing and future services in an evolutionary and cost-effective manner.
- The associated institutional arrangements shall not inhibit competition among service providers complying with relevant ICAO Standards, Recommended Practices and Procedures.

#### 1. Organization, site and dates

The meetings will be held from 8 to 12 June 2009 at the premises of the New Sal Oceanic Control Centre located in the environs of the Amilcar Cabral International Airport and will be sponsored by ASA-Empresa Nacional de Aeroportos e Segurança Aérea, the Cape Verdean Agency for Airports and Air Navigation Services.

#### 3. Passport and Visa requirements

All travelers arriving in Cape Verde should have a valid passport. Cape Verdean entry visas are not required for ECOWAS nationals and of some other countries. Participants are therefore advised to ascertain whether or not they are exempt from visa requirements prior to departure. For those who are not exempt the organization can arrange for entry visa granting upon arrival. Participants on these conditions should report to the Contact Person and forward in advance the following:

- Copy of the passport
- Printed relevant passport data (Number, validity and full identification of the bearer)
- Date of arrival and flight number

The payment of the visa at the amount of 23 Euros (Escudos 2,500) must be made in cash by the applicant.

#### 4. Exchange Rate / Credit cards

The currency used in Cape Verde is the Escudos. Presently, the exchange rate is equivalent to 110 Escudos for 1 Euro and 80.50 Escudos for 1 US Dollar. A 24-hour Exchange Agency is located at the airport as well as main bank agencies in Espargos and Santa Maria. Most of the hotels accept Euros and US Dollars.

American Express and Visa cards are usually accepted in some hotels. Most of the restaurants do not accept credit cards.

#### 5. Local transportation

The organization of the meeting will provide transportation from/to the airport and from/to the site of the meeting. Participants are kindly requested to report to the Contact Person their flight details (arrival and departure dates, flight numbers and hours) and elected hotels during the meeting.

Taxi and mini-bus services are available. The airport taxi tariff to the main hotels in Santa Maria is approximately 800 Escudos during daytime and 1 000.00 Escudos during nighttime. Between Airport and Espargos is approximately 150.00 Escudos.
