

Objectives	

1 INTRODUCTION

- 1.1. The second Meeting of the Steering Committee (SC/2) of the Cooperative Development of Aeronautical Meteorology Services Project in the AFI Region (CODEVMET-AFI) was held virtually from 22 to 23 July 2021.
- 1.2. The meeting adopted and discussed seven (7) agenda items and deliberated on eleven (11) decisions. This working paper presents the status of the implementation these decisions.

2 DISCUSSIONS

2.1. The meeting deliberated on 11 decisions, the implementation of which is summarised in the figure 1 below.



- 2.2. The four decisions in progress include:
 - 2.2.1. Decision 2/1 Continuation of the CODEVMET AFI Project calling for States to support the continuation of the project. Only ten (10) States signed the Project MSA but have not yet committed to sign the revised project document.
 - 2.2.2. Decision 2/3 Signature of the revised MSA by States requesting States/Organizations to sign the revised MSA as soon as it becomes available. Up to date, nine (9) States and one (1) ANSP (ASECNA) signed the MSA.
 - 2.2.3. Decision 2/10 approved the budget for the revised project for 2022, revised the annual contribution of States to UDS10,000.00 and called for Members to pay their outstanding initial contributions to the Project, which is still pending.
 - 2.2.4. Decision 2/11 called for the promotion of the Project, and the implementation of this decision is still ongoing.
- 2.3. Table 1 below provides details on the implementation of the Decisions of the Second Meeting of the Steering Committee of the CODEVMET-AFI Project.
