## 1 INTRODUCTION

- 1.1. The second Meeting of the Steering Committee (SC/2) of the Cooperative Development of Aeronautical Meteorology Services Project in the AFI Region (CODEVMET-AFI) was held virtually from 22 to 23 July 2021.
- 1.2. The meeting took Decision 2/3 calling for ICAO to expedite the revision of the MSA and make it available by the end of September 2021 and urged Members of the CODEVMET AFI Project to sign the revised Management Service Agreement (MSA) as soon as it becomes available.
- 1.3. The MSA constitutes a legal framework of the management of services to be provided by or through ICAO as specified in the Agreement. A detailed description of the Project(s) in

relation to which specific services are going to be provided will be set out in, and designated, as Annex(es) to the MSA, which shall form an integral part of the Agreement.

- 1.4. Through the signature of the Management Service Agreement, the Entity becomes a member of the CODEVMET-AFI steering committee. The Entity that gives power to the Steering Committee, represented by its chairperson, to sign the ProDoc which is Annex to the Management Service Agreement becomes Active member of the project once paying their annual contributions.
- 1.5. This paper provides an update on the status of the membership of the CODEVMET-AFI under its revised version.

## **2 DISCUSSIONS**

- 2.1. As requested by the Second Meeting of the Steering Committee through Decision 2/3, the Secretariat finalized the project MSA and made it available to a first group of States through State Letter T1/3.12 – 0580 dated 28 Dec. 2021 requesting for its Signature.
- 2.2. The revised MSA signed by the Secretary General is being sent to the second group of States for Signature.
- 2.3. A follow-up was made with States to sign the MSA. Up to date, nine (9) States and one (1) ANSP signed the MSA. No State/Organization has given power to the SC to sign the Project Document as Annex to the MSA. The details of the status of the membership are provided in Appendix 1 to this working paper.
