# Introduction

- In order to support the implementation of the **Uniform Methodology** for the identification, assessment and reporting of **deficiencies**, it has been established for the AFI Region, a **web-based platform**, the AFI Air Navigation Deficiencies Database (**AANDD**).
- The AANDD application provides an online tool for **States** and relevant **stakeholders** to manage air navigation deficiencies in the region. The application is accessible through the link: <https://aandd.icao.int>.



# Access to the system - Users

- The following users can have access to the system, provided they were nominated by their Administration/Organization:
  - ICAO Regional Offices users,
  - States users (Focal points and DGCA),
  - Users Organizations Focal points,
  - Professional Organizations Focal points.
- User must authenticate through a valid user account.



# Access to the system - Login

- **Login** with your email and password
- Were you nominated by an Administration/Organization and you still don't have a user account in the system, then **Sign up**, and wait for the activation of your account by the system administrator.
- Did you forget your password, click on "**Forgot password?**" to reset it.



# Reporting deficiencies – Create deficiency

- All users can report a deficiency concerning any State. Deficiency can be reported through 3 options:
  - Click on the menu item **Report Deficiency**
  - From the List of minimum reporting areas, **select** the **Minimum reporting area** then click on the context menu item **Report deficiency**, or on the button [**Report**]
  - From the List of deficiencies, Click on the button [**New**]

  - If the deficiency is successfully saved, an additional box is displayed for the attachments.



# Actions by the State – Corrective actions

- State Focal point **should provide corrective actions** to the deficiency. From the List of deficiencies, when a **deficiency is selected**, its corrective actions display.

# Actions by the State – Corrective actions

- Corrective actions are **created**, **updated** or **deleted** from the **Details** of deficiency:
  - **Select** the deficiency and click on the button [**Details**]
  - Go to the section “**Corrective actions**” and click on the button  to **add** an action,
  - Select an action and click on the button  to **update** it or the button  to **delete** it.




# Actions by the State – Action plan submission

- Once all corrective actions are created in the system, as well as supporting files attached, the action plan should be submitted:

- Select the deficiency
- From the context menu or the menu under the button [Actions], click on item “**Submit the RO CAP**” or “**Submit the APIRG CAP**”

- Regional Office Committee to **validate** the plan, if acceptable

# Actions by the State – Action plan implementation

- After the **corrective action plan** has been **validated** by the ICAO Regional Office Committee, State should **implement** it and **submit** the evidences as follows:
- Update the implementation status of each corrective action
- Upload evidences as attachments to the deficiency

# Actions by the State – Action plan implementation

- Notify the completion of the action plan implementation
  - Select the deficiency
  - From the context menu or the menu under the button [Actions], click on item “*Notify RO CAP implementation*” or “*Notify APIRG CAP implementation*”
  
- Regional Office Committee to review evidences, and close deficiency, if satisfactory

# Reporting to APIRG – Unresolved deficiencies

- When a deficiency confirmed by the ICAO Regional Office Committee was **not timely resolved**, through the normal process, it will be **reported** to **APIRG** for review.
- The status of the deficiency is marked as unresolved.
- The State is notified that the **deficiency is still unresolved** and should be **discussed** at the **APIRG meeting**.
- If APIRG endorses the deficiency, the State is notified and urged to submit action plan.



# Reporting to APIRG – Closed deficiencies

- If corrective actions are taken in time to resolve a deficiency, the case is closed and captured in the AANDD.
- The APIRG meeting is informed of the closed deficiencies.
- The monitoring process of a given deficiency ends after its closure has been reported to the APIRG meeting.
