#### **EXECUTIVE SUMMARY**

This paper presents the budget approved by the Steering Committee of the CODEVMET-AFI Project during its fourth meeting (SC/4), held from 27 to 29 November 2023 and the corresponding expenditures and contributions. It also provides an overview of the payment status of the Member States.

#### 1. INTRODUCTION

- 1.1. During its fourth meeting (SC/4), the Steering Committee of the CODEVMET-AFI Project approved the revised budget for the project as per Decision 4/6.
- 1.2. The paper provides a review of this approved budget, the related expenditures and received contributions for the period from 1 January 2023 to 30 September 2024.
- 1.3. Unless explicitly stated otherwise, all amounts in this paper are given in United States dollars.

#### 2. **DISCUSSION**

- 1.1. The situation of the 2023/2024 budget is as follows:
  - a) The approved budget for 2024 as per Codevmet SC/5 Decision 4/6 stands as \$127,500 as provided in Appendix 1 to his working paper.
  - b) The adjusted Balance of Surplus as at 1 January 2024 amount to \$105,342 as at 1 January 2024.

- c) The contributions received as at 31 August 2024 amount to \$65,818. The deduct expenses include the missions (\$51,205), the sundry, and the administrative overhead (\$114). The fund balance as at 31 August 2024 is then \$114,531.
- d) The deduct outstanding commitments known up to 31 December 2024 include mission costs (1,138) and administrative overhead (\$114). The estimated fund available as at 31 August is \$113,279. Details of this financial statement are provided of in Appendix 2 to this working paper.
- e) The summary of the budget as at 31 August 2024 is shown in the table below.

- f) In September 2024, the project recorded on assistance mission with an estimated total cost of \$10,000, corresponding to the mission to Senegal. The details are provided in Appendix 1 to this WP. The cost of the SC/5 meeting is also estimated at \$22,500 in the 2024 approved budget. These costs may change (up or down) in the normal financial statement expected during the first half of October 2024.
- g) Taking into account the expenses mentioned in f), the balance of the budget as of September 30, 2024 is estimated at \$80,779. This amount could change (up or down) for the reasons mentioned above.

#### 1.2. Status of payment requests

- a) ICAO issues payment requests for annual membership fees. Should on-request services be required, corresponding payment requests will be issued as well.
- b) As at 30 November 2024, a total amount of \$236,622 of annual membership fees is outstanding. The details are provided in Appendix 4.

#### 1.3. Conclusion

- a) The project budget which was approved during SC/4 was not fully implemented as planned until September 2024.
- b) The differences between the baseline and the actuals are mainly due to contributions of some members and the rescheduling of activities.

c) As at 30 September 2024, the project has a balance of close to \$103,279, while the arrears amount to slightly over \$230,000.
