In addition, and in order to ensure both certification bodies and accreditation bodies have the relevant knowledge, ISCC conducts regular dedicated ISC CORSIA trainings, covering all important aspects of CORSIA eligible fuels and the ISCC CORSIA certification programme.

In case of noncompliant behaviour of certification bodies and their representatives, ISCC may impose sanctions in line with what is laid down in the 102 CORSIA System Document, p. 23 (which may include the termination of the cooperation agreement depending on the severity of non-compliance).	No suspensions or terminations of certifications or certification bodies due to detected non-conformities during calendar year 2021.	As referenced above, ISCC has set up a dedicated ISCC CORSIA training programme, aimed at equipping all participants with relevant knowledge regarding the certification of CORSIA eligible fuels and ISCC CORSIA certification in particular. The trainings cover a comprehensive set of topics (please see information in field 4e) and are aimed at representatives from certification bodies, accreditation bodies, economic operators, government bodies and other third parties. In addition, auditors have to successfully complete an auditor test following their participation in the ISCC CORSIA training, ensuring they have the relevant CORSIA-specific
