2024 ICAO Regional Seminars on Environment


The 41st Session of the ICAO Assembly in 2022 adopted the collective long-term global aspirational goal (LTAG) for international aviation of net-zero carbon emissions by 2050, and the Third Conference on Aviation and Alternative Fuels (CAAF/3) in 2023 adopted the ICAO Global Framework on Sustainable Aviation Fuels (SAF), Lower Carbon Aviation Fuels (LCAF) and other aviation cleaner energies.

In this regard, ICAO is organizing five Environmental Regional Seminars across various ICAO regions from August-September 2024 with the objectives of raising awareness and exchanging views on the implementation of the LTAG and Global Framework, including recent developments on aviation cleaner energy policies and State Action Plans, CORSIA as the basis for the eligibility of aviation cleaner energies, implementation challenges and the ACT-SAF programme, and financing for aviation cleaner energies, as well as the means for monitoring the progress for the implementation of the LTAG and Global Framework. State Letters have been sent out.

Progress on certification of CORSIA Eligible Fuels

The CORSIA-Approved Sustainability Certification Schemes (SCSs) have submitted reports covering their certification activities in 2023. These reports are now available on the CORSIA website, and they show a substantial increase of in the certification of CORSIA eligible fuels: the number of certified CORSIA SAF batches increased from 9 to 30 batches, totaling 11.2 kilotonnes (kT) of CORSIA SAF, compared with 1.5kT certified in 2022. The number of CORSIA-certified economic operators, including feedstock producers, traders and fuel producers, also increased from 41 to 98.

The reports provide information on the certifications performed up to 31st December of 2023. More up to date information is available on the websites of the ICAO-approved SCSs (ISCC and RSB).

ICAO – COCESNA Webinar 'Driving a Sustainable Future in International Civil Aviation'

- Following the participation of the Central American Corporation for Air Navigation Services (COCESNA) in ACT-SAF; ICAO, jointly with the ICAO NACC Regional Office and COCESNA, organized a webinar on 'Driving a Sustainable Future in International Civil Aviation' on 17 July 2024
 - More than 50 participants from the civil aviation authorities of Belize, Dominican Republic, Ecuador, El Salvador, Guatemala, Honduras, Mexico, Nicaragua, Panama, Peru and Spain; air operators, COCESNA, EASA and other international organizations attended the event
 - With these activities, COCESNA will further promote its efforts in its 'Alliance for Sustainable Aviation (ALAS)' initiative, seeking the developments in the region for SAF, SAF-LCAF as key elements in decarbonization of the sector

ACT-SAF Business Implementation Template

As a follow up to the ACT-SAF feasibility study template/guide, ICAO is finalizing a draft template to support SAF business implementation. This provides additional support to States where preceding studies have already identified SAF feedstock/pathway prospects, facilitating future final investment decisions to drive the start of concrete SAF projects. In doing so, the template supports the ICAO Global Framework for SAF, LCAF and other Aviation Cleaner Energies, in particular in Building Block 3 — Implementation Support, in supporting a 'project's readiness to attract investment, including training on financial aspects of project development, financial planning and investment promotion' (Paragraph 18g), and Building Block 4 — Financing, to 'initiate specific measures or mechanisms so as to facilitate, in particular for developing countries and States having particular needs, better access to private investment capacities, as well as funding from financial institutions' (Paragraph 26a).

The **2024 ICAO Symposium on non-CO₂ Aviation Emissions** (16-18 September 2024) aims at raising awareness on non-CO₂ emissions from aviation operations, and creating synergies across different stakeholders. The **three-day event will be held in-person**, at ICAO Headquarters, Montréal, Canada, and will focus on taking stock of the scientific knowledge on non-CO₂ effects and sharing the work undertaken by all relevant stakeholders, as well as exploring future activities and measures to potentially mitigate and address these effects, considering the existing scientific uncertainties. The 2024 ICAO LTAG Stocktaking on Aviation CO2 Emissions Reductions (7-10 October 2024) will be held in-person, at ICAO Headquarters, Montréal, Canada, and will build upon the continued success of the annual ICAO Stocktaking events held since 2019, providing a response to the 41st Session of the ICAO Assembly's request to monitor the progress towards the achievement of the collective LTAG for international aviation of net-zero carbon emissions by 2050, as well as the Third Conference on Aviation and Alternative Fuels (CAAF/3) request to monitor the

implementation of the ICAO Global Framework on SAF, Lower Carbon Aviation Fuels (LCAF) and other aviation cleaner energies. Registration is open!
