APPLICATION OF THE ULD TAG FOR MAGNETIZED MATERIAL

SUMMARY

This paper proposes a revision to Part 7;1.4.2 to remove reference to a requirement for a dangerous goods unit load device (ULD) tag for ULDs containing magnetized material.

Action by the DGP: The DGP is invited to revise Part 7;1.4 to remove reference to magnetized material as shown in the appendix to this working paper.

1. **INTRODUCTION**

- 1.1 The provisions applicable to the classification and shipping of magnetized materials were revised with effect the 2011–2012 Edition of the *Technical Instructions for the Safe Transport of Dangerous Goods by Air* (Doc 9284). The changes introduced at that time largely deregulated the preparation and transport of magnetized materials.
- 1.2 It has been identified however that in Part 7;1.4 which addresses the provisions for certain, limited types of dangerous goods to be accepted by the operator when in a shipper prepared unit load device, there is still a reference to magnetized material, including in 7;1.4.2 that the operator must apply a dangerous goods unit load device (ULD) tag to ULDs containing magnetized material.
- 1.3 Here it is questioned as to whether this requirement is still valid particularly as in Part 7;2.8 the requirement to apply the dangerous goods ULD tag only applies when the ULD contains packages of dangerous goods that bear a hazard label. As packages of magnetized material do not bear a hazard label it would appear that it is not necessary for such ULDs to identify the presence of the magnetized material.

PROPOSED AMENDMENT TO PART 7 OF THE TECHNICAL INSTRUCTIONS

Part 7

OPERATOR'S RESPONSIBILITIES

Chapter 1

ACCEPTANCE PROCEDURES

• •

1.4 ACCEPTANCE OF FREIGHT CONTAINERS AND UNIT LOAD DEVICES

- 1.4.1 An operator must not accept from a shipper a freight container or a unit load device containing dangerous goods other than:
 - a) a freight container for radioactive material (see 6;7.1);
 - a unit load device or other type of pallet containing consumer commodities prepared according to Packing Instruction Y963;
 - c) a unit load device or other type of pallet containing dry ice used as a refrigerant for other than dangerous goods prepared according to Packing Instruction 954; or
 - d) a unit load device or other type of pallet containing magnetized material.
- 1.4.2 When an operator accepts a unit load device or other type of pallet containing consumer commodities, or dry ice-or magnetized material as permitted by 1.4.1, the operator must attach an identification tag as required by 2.8.1 to the unit load device.
