**TWENTY-SIXTH MEETING OF THE DANGEROUS GOODS PANEL (DGP)**

**Montréal, 16 to 27 October 2017**

**SUPPLEMENT NO. 1**

The Council, at the sixth meeting of its 213th Session on 9 March 2018 and the Air Navigation Commission, at the fifth meeting of its 207th Session on 1 February 2018, under authority delegated by the Council, took action on the recommendations of the twenty-sixth meeting of the Dangerous Goods Panel (DGP/26), as indicated hereunder.

**1. RECOMMENDATIONS FOR AMENDMENT OF  
STANDARDS AND RECOMMENDED PRACTICES  
AND PROCEDURES (RSPP)**

The Air Navigation Commission made a preliminary review of Recommendation 1/1 and agreed that it should be referred for comments to Contracting States and appropriate international organizations, together with the Commission's own comments and proposals thereon. Following receipt of comments, the Commission will conduct a detailed review and will then present its recommendations for action by the Council. The Air Navigation Commission did not consider Recommendation 6/4 to be sufficiently mature to be referred to Contracting States and international organizations for comment and requested that it be revised in a manner which would foster consistent global implementation.
