AMENDMENT TO PACKING INSTRUCTION 964 & PACKING INSTRUCTION Y964

SUMMARY

This working proposes an amendment to clarify the applicability of the general packing requirements in Packing Instruction 964 and Packing Instruction Y964.

Action by the DGP-WG: The DGP-WG is invited consider the revisions to Packing Instructions 964 and Y964 as shown in the appendix to this working paper.

1. **INTRODUCTION**

1.1 At the Twenty-Second Meeting of the Dangerous Goods Panel Meeting (DGP/22, Montreal, 5 to 16 October 2009), a decision was made to remove the requirement for the pressure differential test contained in Part 4;1.1.6 of the Technical Instructions when transporting UN 3082 — **Environmentally hazardous substance, liquid, n.o.s.*** (see paragraph 2.3.2 of the DGP/22 Report). An exception was incorporated in Packing Instructions 964 and Y964 as follows:

Packing Instruction 964:

"General requirements

Except for UN 3082 when the requirements of 4;1.1.6 do not apply, Part 4, Chapter 1 requirements must be met, including:"

Packing Instruction Y964:

"General requirements

Except for UN 3082 when the requirements of 4;1.1.6 do not apply, Part 4, Chapter 1 requirements must be met (except that 4;1.1.2, 1.1.9 c), 1.1.9 e), 1.1.16, 1.1.18 and 1.1.20 do not apply), including:"

1.2 The text as written is creating a lot of confusion and is open to different interpretations. It is not absolutely clear that, only for UN 3082, the pressure differential requirements do not apply.

2. **ACTION BY THE DGP-WG**

2.1 The DGP-WG is invited to discuss and adopt the amendment to Packing Instruction 964 and to Packing Instruction Y964 proposed in the appendix to this working paper.
