#### **SUMMARY**

Using the index to the Technical Instructions provides one of the easiest methods for locating specific information.

Members of the DGP are asked to keep in mind that where they find items in the Technical Instructions that they refer to regularly are not able to be found using the index it helps other users if these are included.

## 1. **INTRODUCTION**

- 1.1 The index to the Technical Instructions is a very handy resource for locating specific requirements. There is a need to ensure that the index makes the document user friendly and includes common items.
- 1.2 I have recently submitted the following items to the Secretariat for consideration of inclusion in the index to assist. Users of the Technical Instructions often have trouble locating the information listed.
