OVERPACKS CONTAINING “CARGO AIRCRAFT ONLY” DANGEROUS GOODS

(Presented by G A Leach)

SUMMARY

This paper proposes to re-visit DGP-WG/08-WP/36 concerning overpacks containing “cargo aircraft only” dangerous goods, which proposed deletion of Part 5; 1.1 e) and Part 7; 1.3 j), on the basis that amendments made to Part 7 by DGP/21 make these provisions redundant.

Action by the DGP-WG is in paragraph 2.

1. INTRODUCTION

1.1 Part 5;1.1 e) of the Technical Instructions specifies the conditions under which an overpack can contain “cargo aircraft only” dangerous goods, i.e.:

- 1) the packages are assembled in such a way that clear visibility and easy access to them is possible; or
- 2) the packages are not required to be accessible under 7;2.4.1; or
- 3) not more than one package is involved;

1.2 At the DGP Working Group of the Whole at the Hague (DGP-WG/08), DGP-WG/08-WP/36 (see the appendix to this working paper) proposed the deletion of the above text on the basis that changes to Part 7 agreed at DGP/21 made it redundant. Whilst there was some support for the proposal the report of the meeting records that “It was agreed further discussion of the consequences arising from the amended provisions would be helpful; new proposals would be brought to DGP-WG/09.” Regrettably a new proposal was not presented at DGP-WG/09.

1.3 Questions continue to be received from shippers and operators alike on this subject and it is suggested it is re-visited by the working group.

2. ACTION BY THE DGP-WG

2.1 The DGP-WG is invited to re-visit DGP-WG/08-WP/36 presented in the appendix and if agreed adopt the proposal made in that working paper.

OVERPACKS CONTAINING “CARGO AIRCRAFT ONLY” DANGEROUS GOODS

SUMMARY

This paper proposes to delete Part 5; 1.1 e) and Part 7; 1.3 j) which relate to overpacks containing cargo aircraft only dangerous goods. Amendments made to Part 7 by DGP/21 make these provisions redundant.

Action by the DGP-WG is in paragraph 2.

1. INTRODUCTION

1.1 At DGP/21, the provisions in Part 7 of the *Technical Instructions for the Safe Transport of Dangerous Goods by Air* (Doc 9284) concerning the accessibility of packages and overpacks containing cargo aircraft only dangerous goods were clarified. This involved the deletion of the requirement for all hazard warning labels and the “cargo aircraft only” label on packages or overpacks to be visible after packages or overpacks had been loaded. Consequently, the *2009-2010 Edition* of the Technical Instructions allows cargo aircraft only dangerous goods to be grouped together such that only the labels on the outer packages or overpacks are visible i.e. those behind the outer packages and overpacks need not have their labels visible. Additionally, such packages and overpacks may now be loaded without accessibility in a Class C cargo compartment.

1.2 No corresponding change was made to Part 5;1.1 e), the General Requirements of the Shipper's Responsibilities which currently states the following:

- e) an overpack is used for packages bearing the "Cargo aircraft only" label only if:
 - 1) the packages are assembled in such a way that clear visibility and easy access to them is possible; or
 - 2) the packages are not required to be accessible under 7;2.4.1; or
 - 3) not more than one package is involved;

1.3 The changes made to Part 7 at DGP/21 indicate that the current provisions of 5;1.1 e), relating to overpacks containing cargo aircraft only dangerous goods are now redundant; if they are loaded in a compartment not meeting the Class C requirements (and so require accessibility) it is the overpack and not the individual packages which need to be accessible, thus it is academic how the packages are assembled or the number which are contained within; if they are loaded in a Class C compartment (and so are not accessible) none of 5;1.1 e) can apply.

2. ACTION BY THE DGP-WG

2.1 The DGP-WG is invited to delete:

- a) Part 5;1.1 e) (with the consequent re-numbering of subsequent paragraphs); and
- b) Part 7; 1.3 j) which requires the operator to verify that 5;1.1. e) has been complied with as part of the acceptance check.
