### **EXECUTIVE SUMMARY**

This paper presents information on the implementation of the Decisions and Recommendations of the 14<sup>th</sup> AFI Plan Steering Committee meeting which was held on 24 October 2014 in Montreal, Canada and the status of implementation of the 2015 work programme.

**Action:** The Steering Committee is invited to:

- d) Note the related information contained in Discussion Papers 02, 03 and 04.

### 1. **INTRODUCTION**

- 1.1 The Steering Committee at its 14<sup>th</sup> meeting had reviewed the actions taken since its thirteenth meeting on the implementation of the AFI Plan and approved the proposed 2015 AFI Plan activities and Work Programme.
- 1.2 This paper summarizes the progress made in the implementation of the Decisions and Recommendations of the 14<sup>th</sup> meeting of the AFI Plan Steering Committee and the status of implementation of 2015 the Work Programme.

### 2. SUMMARY OF PROGRESS: OCTOBER 2014 – MAY 2015

- 2.1 The list of Decisions and Recommendations of the 14<sup>th</sup> meeting of the AFI Plan Steering Committee along with an update on actions undertaken so far as well as actions required from this meeting are attached herewith as **Attachment A**. On the other hand, the status of implementation of the 2015 Work Programme is presented as **Attachment B** to this Discussion Paper.
- 2.2 As per Recommendation Rec/03 and Decision Dec/04 of the 14<sup>th</sup> AFI Plan Steering Committee meeting a progress report on the status of implementation of the Abuja safety targets is presented by AFCAC in **Discussion Paper 02** of this meeting.
- 2.3 With regard to the information on available courses and training organizations in Africa, a progress report is presented by GAT, AATO and Morocco in **Discussion Paper 03** of this meeting.
- 2.4 A draft training needs roadmap for Africa is presented by AATO in **Discussion Paper 04** of this meeting.
- 2.5 With regard to Regional Safety Oversight Organizations (RSOOs) and Regional Accident and Incident Investigation Organizations (RAIOs), the SC/14 meeting recommended that work continues with each sub-region for the establishment and operationalization of such entities, which is still pending. The ICAO ESAF Office is reviewing the recently completed Study on the establishment of an RSOO for Arab Civil Aviation Commission (ACAC) and ICAO Middle East (MID) Region States, including Egypt, Libya and Sudan which are among the Seven Partner States. South Sudan working arrangements with the Civil Aviation Safety and Security Oversight Agency (CASSOA) will be determined by the general cooperation framework with the East African Community (EAC) which is under consideration. These developments will affect the scope of the RSOO/RAIO of the initial Seven Partner States.
- 2.6 A transition plan for the operationalization of the SADC Safety Oversight Organization (SASO) was approved. The COSCAP-SADC Project, in collaboration with the SADC Secretariat, is working to facilitate the administrative and logistical processes of setting up an interim Secretariat of SASO.
- 2.7 The MOU concluded between AAMAC, CEMAC and UEMOA for the separation of functions of their respective RSOOs in line with the Abuja Declaration, and signed by AAMAC and CEMAC since May 2014, is still yet to be signed by UEMOA. The WACAF regional office has intensified follow up with the President of the UEMOA Commission for signature of the document during the planned visit of the ICAO Secretary General to Burkina Faso in May 2015 following the AFI Aviation Week events in Maputo.
- 2.8 Two additional States, Tanzania and Burundi signed the AFI-CIS MOU since the last 14<sup>th</sup> SC meeting which brings the total number of States that have signed the MOU with AFCAC to 36. Priority States have been identified for AFI-CIS Assistance missions in anticipation of cost recovery from States. Despite the terms laid out in the MoU and sensitization by the AFCAC President and Secretary General, some States are reluctant to accept the cost recovery principle as stipulated in the signed MoU. ICAO is supporting the AFI-CIS with SAFE funds for assistance missions to States.
- AFCAC has repeatedly requested States to provide information to assist in monitoring the status of implementation of the Abuja safety targets. Following the 14<sup>th</sup> AFI Plan Steering Committee meeting, a joint letter signed by AFCAC and ICAO was also sent to States to request the same. However, the response from the States is not encouraging. In the meantime to overcome this challenge and conduct the monitoring and evaluation exercise during the 2015 Work Programme, a Project Group (PG) comprising AFCAC, ICAO, IATA and ACI was established under the aegis of RASG-AFI. Following its establishment, the PG met twice and some progress was made in gathering the required information for completion of the evaluation before end of 2015. AFCAC will report on the status of implementation of the Abuja Safety Targets thus far, in DP 02.

- 2.10 The first meeting of the African Flight Procedure Programme (AFPP) Steering Committee (SC) was held from 16 to 17 December 2014 in Nairobi, Kenya. During this meeting, in line with the 14<sup>th</sup> AFI Plan Steering Committee Recommendation Rec/08, the membership of the AFPP Steering Committee was extended to include Donor States and AFCAC, in addition to the Active Participating States, the Host Administration and ICAO. Accordingly, the African Civil Aviation Commission (AFCAC) and France became members of the AFPP Steering Committee.
- 2.11 The EU project for "Support to the Improvement of Aviation Safety in Africa" (SIASA) which is to assist States in improving the implementation of ICAO safety standards and in resolving safety deficiencies, including Significant Safety Concerns (SSCs) as well as training and support to Regional Safety Oversight Organizations (RSOOs) in Africa, is ongoing.
- 2.12 The support by United States Department of Transportation Safe Skies for Africa Program (SSFA) and the Federal Aviation Administration (FAA) is ongoing. Accordingly and in collaboration with the Tanzania Civil Aviation Authority (TCAA), a seminar on "Improving the Safety of Air Traffic Services through Independent Oversight" was conducted from 17 to 20 March 2015 in Dar es Salaam, Tanzania.
- 2.13 In the area of training, the following actions have been undertaken:
  - a) OPS and PEL Inspector French course material is under development by Morocco and may be available tentatively in 2015.
  - b) <u>Courses and Workshops</u>: The following Courses and Workshops were successfully conducted as follows:
