A. Project justification

- 1. The need for the provision of effective Search and Rescue (SAR) services and regional collaboration and cooperation through pooling of resources have become important global agenda items following recent aircraft accidents within oceanic search and rescue regions (SRRs) that have posed serious challenges to search and rescue organisations in the discharge of effective SAR operations.
- 2. At its Fourteenth Meeting in Yaoundé, Cameroun in June 2003, the AFI Planning and Implementation Regional Group (APIRG/14) identified the need for States to be continuously sensitized in order to take necessary remedial action to implement ICAO provisions relating to SAR, and consequently adopted Conclusion 14/28 'Organization of Regional SAR Seminars/Workshops' which was updated by Conclusion 19/53 and adopted by the APIRG/19 Meeting in Dakar, Senegal in October 2013.
- 3. Upon the completion of a Special Meeting on Global Flight Tracking of Aircraft (Montreal, 12-13 May 2014), which was prompted by disappearance of Malaysian Airlines flight 370 on 8 March 2014, ICAO Member States and the International air transport industry sector agreed on the near-term priority to track airline flights, no matter their global location or destination.
- 4. The provision of effective SAR services entails the mobilization of essential State assets including those of military forces and other State institutions. Additionally, assets of neighbouring States and other organizations can support an effective and efficient allocation of resources to the search area, including rescue of the victims who can be provided with immediate medical assistance, thereby increasing their chances of survival. In most circumstances, the release of SAR assets from neighbouring States would normally require negotiations and approval at high level within States' authorities which can be time consuming, unless there are pre-arrangements through formal agreements to expedite the process and level of assistance rendered.
- 5. The sixteenth meeting of the AFI Plan Steering Committee (Montreal November 2015) identified the need for urgent action to increase the capacity of AFI States to provide effective SAR services and recommended that SAR be included in the AFI ANS Performance Indicators and Targets. The Steering Committee further requested the AFI Plan Secretariat to develop and implement projects to assist States in key priority areas including SAR organisation. In line with this decision, , the APIRG/20 meeting adopted a set of AFI ANS key Performance Indicators and Targets among which is the establishment of effective and operational SAR Organization.
- 6. This project focuses on the existing regional SAR frameworks in 12 States of Botswana, Kenya, Madagascar, Mauritius, Mozambique Namibia, Seychelles, Somalia, South Africa, Rwanda, Tanzania and Uganda which are within the Indian Ocean and eastern and southern African sub-regions.

B. End of Project Status/ Target / Overall Objective

1. By the end of the project, the SAR organization in the 12 beneficiary States will be more effective as the legal framework and SAR plans would be in place, more agreements would have been signed, supporting collaborative efforts to SAR organisation and operations. Furthermore, the awareness on SAR will have increased among SAR stakeholders across the AFI Region, generating more resources that could be made available for SAR.

2. Implementation strategy

- 2.1 The project will be implemented by ICAO ESAF Regional Office and a team of four experts from among ESAF States who will provide technical support on a need basis via missions and remote documentation review and drafting.
- 2.2 The initial stage of the project will consist of a gap analysis for the Technical Expert Team (TET) to have up to date information on the current level of implementation in each beneficiary State which will constitute the basis for designing the details of the assistance to be provided to each State.
- 2.3 This assistance will comprise an initial meeting followed by assistance/facilitation activities to beneficiary State in the development of a legal framework (legislation/regulation), SAR plan of operation and SAR letters of agreement (LOAs) for formal acceptance and signing by the appropriate authorities as part of regional cooperation. The project will also evaluate the level of implementation of an RCC/JRCC/RSC in each State, as the case maybe with supporting resources. A second meeting is planned in March 2017 to review progress of implementation among the beneficiary States and to identify areas requiring additional assistance.
- 2.4 Sensitization actions will also be required at a senior level in States' civil and military authorities responsible for SAR services to facilitate the successful completion of this project.

D. Inputs:

1. **Input from States**

- 1.1 **Counterparts**: SAR Focal points designated by each CAA will provide assistance in coordination and follow-up for their respective States. The coordination will englobe all States' entities involved in the provision of search and rescue services.
- 1.2 **Support staff**: States will provide ICAO staff with experts and support staff as necessary.
- 1.3 **Office(s)**: States will provide their SAR Focal Point of Contact with the necessary tools (telephone, internet, printer, meeting room etc.) for on-site activities and effective coordination with the TET.
- 1.4 **Meeting**: Each State will ensure the participation of its focal point as well as other key stakeholders at the meetings. The first meeting will be hosted at ESAF Regional Office in Nairobi and will cover the cost of participating SAR experts from donor States.
- 1.5 **Transport**: States will provide local transportation to ICAO Regional Officers and SAR experts while on site. States will also facilitate obtaining entry visas for the TET including any other assistance that may be necessary for the fulfilment of their missions.

2. ICAO Input

- 2.1. **Funding for the project**: The project will be funded by AFI Plan as indicated in Appendix A to this document.
- 2.2. **Experts**: ICAO ESAF Office will rely mainly on the Regional Officers, ATM/SAR in Nairobi and SAR experts seconded by donor States to support the project.
- 2.3. **International missions**: All costs related to assistance missions to the beneficiary States and meetings organized by ICAO ESAF Office for the TET will be covered under this project. Applicable DSA and airfares for each mission will be covered under the project funds.
- 2.4. **Monitoring and reporting**: ICAO Regional Office in Nairobi will be responsible for the supervision of the project and the production of the Project Terminal report. It will also establish and maintain coordination with all the stakeholders during the course of the project.
- 2.5. **Miscellaneous expenses:** Contingency funds will be provided under the project as indicated in Appendix A to this document.
