Outcomes of the Meeting

The meeting formulated 38 conclusions and 11 Decisions and also:

- **Approved the new APIRG structure**
- **Proposed the new ANS Targets for consideration and approval by the RASG-AFI**
- **Agreed to apply the new Regional Air Navigation Plan Template approved by the ICAO Council; and the finalise of the AFI eANP**
