EXECUTIVE SUMMARY

This paper presents information on the status of implementation of the Decisions and Recommendations of the 21st meeting of the AFI Plan Steering Committee held on 17 July 2018 in Niamey, Niger as well as the 2018 AFI Plan Work Programme.

Action: The Steering Committee is invited to:

- d) Provide further instructions and guidance for the continued implementation of the 2018 Work Programme considering the status of implementation (Colum 4 of Attachment B)

1. INTRODUCTION

1.1 The AFI Plan Steering Committee at its 21st meeting had reviewed the actions taken since its twentieth meeting on the implementation of the AFI Plan activities and in so doing, took some additional Decisions and made Recommendations on the 2018 Work Programme.

1.2 This paper summarizes the progress made in the implementation of the above referred Decisions and Recommendations and the 2018 Work Programme.

2. SUMMARY OF IMPLEMENTATION PROGRESS SINCE JULY 2018

- 2.1 The list of Decisions and Recommendations of the 21st meeting of the AFI Plan Steering Committee (SC/21) along with an update on actions undertaken and / or required from this meeting are attached herewith as Attachment A. Similarly, the progress made so far in implementing the 2018 Work Programme is presented as Attachment B to this paper.
- 2.2 In accordance with the guidance provided at the SC/21 meeting on the development of a Strategic Plan for supporting and strengthening Regional Safety Oversight Organizations (RSOOs) in Africa, ICAO ADB was approached for the recruitment of a consultant to carry out the study. The recruitment process has thus been launched and the study expected to commence in the third quarter of this year, 2019.
- 2.3 The implementation of AFI Plan projects approved at the 17th and 20th SC meetings on Aerodrome certification, Search and Rescue (SAR) coordination, State Safety Programme (SSP) establishment, Air Navigation Service Provider (ANSP) peer reviews, Accident Investigation (AIG), and the Fundamentals of Safety Oversight (FSO) are progressing. The implementation status of each project including a new project proposal on Aeronautical Information Management (AIM) is to be presented to this meeting in **DP-02**.
- In accordance with the ICAO Council decision related the Declaration and Framework for a Plan of Action for Development of Aviation Infrastructure in Africa and implementation of activities assigned therein to ICAO, the AFI Plan conducted an Aviation Infrastructure for Africa Gap Analysis exercise covering Airports, Air Navigation Services, and Aircraft fleet capacity and equipage. For this purpose, information was gathered through ta State survey complemented with material from the ICAO database and other sources, and a preliminary gap analysis on current requirements and status of aviation infrastructure in Africa carried out. The results of this gap analysis were presented and reviewed in a workshop held in Abuja, Nigeria from 19 to 21 March 2019. The outcome of the workshop and results of the Gap Analysis will be presented in DP/ 03.
- 2.5 AFCAC has been following up on the implementation of the revised Abuja Safety targets and Air Navigation Performance Indicators and Targets. A status report will be presented by AFCAC, in DP 04.
- 2.6 The AFI Plan Secretariat continues to provide support to AATO. In this regard and in line with the relevant SC 21 Decision, a meeting of stakeholders was held in Doha, Qatar, on the side of the 5th Global Aviation Training and TRAINAIR Plus Symposium, to review the draft African Aviation Training Roadmap review meeting in collaboration with GAT in. Key stakeholders provided useful feedback to improve and finalize the training roadmap. AATO will present the reviewed roadmap to this meeting in DP/05.

- 2.7 The Regional Office Safety Teams (ROSTs) have been active in assisting States in the implementation of their USOAP Corrective Action Plans (CAPs). Accordingly, since the 21st meeting, assistance missions were conducted to 6 States (namely: Angola, Zimbabwe, Lesotho, Burundi, Comoros and Malawi) in the ESAF region, and 10 States (namely: Chad, Congo, Cote d'Ivoire, DRC, Gabon, Ghana, Liberia, Mauritania, Nigeria and Senegal) in the WACAF region.
- 2.8 The increased assistance and engagement with States resulted in a corresponding improvement of EIs in both ESAF and WACAF regions. Accordingly, 30 States in Africa have currently achieved more than 60% EI. Other notable progress is seen in the implementation of the Aerodrome Certification Project, through which assistance provided led to the certification of 12 international Airports (Abidjan, Bamako, Lagos, Abuja, Niamey, Libreville, Dakar, Maputo, Lusaka, Kigali, Manzini and Windhoek) in eleven beneficiary States.
- 2.9 High-level engagements continued with African States including those countries with low EIs and slow progress in the implementation of their ICAO Plans of Action. In this regard, in 2019 the ICAO Council President met with some selected States during the Aviation infrastructure for Africa Gap Analysis Workshop held in Abuja, Nigeria. The same is planned for the Secretary General during this 6th AFI Aviation Week in Kampla, Uganda, for which a number of side meetings have been scheduled over the dates 14-17 May 2019.
- 2.10 The support from the United States Department of Transportation Safe Skies for Africa (SSFA) Program and the Federal Aviation Administration (FAA), the EU funded projects as well as other partners, aimed at assisting African States in improving the level of implementation of ICAO safety standards, is on-going. The meeting will be provided with more detailed information on the various initiatives during the session on Presentations by Partners.
