EXECUTIVE SUMMARY

This paper presents information related to the proposed programme of activities and required budget under the AFI Plan for the year 2019.

Action: The Steering Committee is invited to:

- a) Note the information contained in the paper; and
- b) Consider and approve the proposed 2019 AFI Plan Work Programme and budget.

1. **INTRODUCTION**

This paper presents the proposed work programme of activities and budget under the AFI Plan for the year 2019. The programme was prepared considering the status of implementation in 2018, the initiatives and targets set for 2019 and in accordance with the proposed updated Programme Document following approval for continuation of the AFI Plan beyond 2016.

2. SUMMARY OF PROGRESS -2018

- During its twenty first meeting, the Steering Committee reviewed the progress made in the implementation of the programme of activities that have been conducted under the AFI Plan for the year 2018. Since then further progress has been made as discussed under Agenda item 1 with the deferment of some activities to 2019.
- 2.2 In view of the call for revision of the calendar of AFI Plan meetings, the Steering Committee meeting usually held towards the end of each year, during the course of which the work programme for the subsequent year is considered and approved, was deferred and not held

in 2018. However, for the purpose of ensuring non-interruption of programme activities, the proposed work programme for 2019 was considered and endorsed through consultations between the Secretariat, the SC Chairperson and the Office of the ICAO Secretary General. A number of activities have therefore been implemented or are ongoing.

3. PROPOSED WORK PROGRAMME FOR 2019

- 3.1 The formulation of the 2018 AFI Plan work programme takes into account the 39th Assembly decision which extended the implementation of the programme beyond 2016, for the and the expansion of the programme activities to include AIG, AGA and ANS. It also took in to account the initiatives and specific targets indicated in the updated (2017-2020) AFI Plan work programme and the ICAO Council decision that relevant aspects of the Declaration and Framework for a Plan of Action for Development of Aviation Infrastructure in Africa should be implemented under the ICAO Comprehensive Regional Implementation Plan for Aviation Safety in Africa (AFI Plan). Furthermore, the proposed 2019 work programme considered the progress made in achieving the annual targets set for 2018 relating to the removal of all Significant Safety Concerns (SSCs), increase of EI levels and certification of International airports. The programme also includes implementation of the revised regional Safety and Air Navigation targets. The details of the activities, the associated budget and specific targets to be achieved by the end of 2019 under each focus area, are provided as Attachment A to this Discussion Paper.
- 3.2 In terms of assistance to States, efforts towards development and effective implementation of ICAO Plans of Action are to be maintained with continued support by the Regional Office Safety Teams (ROSTs), coupled with working visits by States to the Regional Offices. Assistance delivery by AFI-CIS, TCB Projects, COSCAPs/RSOOs and other partner programmes will also be coordinated and conducted within the framework of the ICAO Plans of Action.
- In response to Decision C-DEC 24/7 of the 213th and 214th Sessions of the ICAO Council that ICAO activities relating to the Declaration and Framework for a Plan of Action for Development of Aviation Infrastructure in Africa should be implemented under the AFI Plan, the 2019 programme includes a workshop to be conducted as part of the Aviation Infrastructure for Africa Gap Analysis. On-going AFI Plan projects have been incorporated in this year's activities to ensure their effective implementation and completion. One new project proposal on Aeronautical information Management (AIM), developed at the request of the 21st Steering Committee meeting, and two Workshops for the development of National Aviation Safety Plans, are also reflected in the 2019 programme, for consideration by the SC, subject to approval of the same under action on DP-02.
- 3.4 With regards to Regional Safety Oversight Organisations (RSOOs) and Regional Accident Investigation Organizations (RAIOs), the engagement of a consultant to develop a Strategic Plan for supporting and strengthening RSOOs in the Region, as per the Ezulwini Declaration of 2017, is being finalized following guidance received from the 21st SC meeting. Activities related to this study, which are expected to be completed in the course of the current year, feature in the proposed programme.

- 3.5 On the basis of the Recommendation of the Report on the Evaluation of AFI Plan, it is proposed to continue to facilitate the delivery of inspector training and related safety courses in the areas of Operations, Airworthiness, and Personnel Licensing, Aerodromes and Ground Aids, and Air Navigation Services, in close collaboration with GAT and the Human Resource Development Fund (HRDF) for Africa as well as the ICAO Endorsed training institutions in Africa.
- 3.6 The AFI Plan, as part of its activities of 2019 will also continue to serve as a coordination platform for the programs, projects and initiatives of Partners.
