# **EXECUTIVE SUMMARY**

This paper presents the AFI Plan programme activities and budget for the remaining period of 2023 and 2024.

**Action:** The Steering Committee is invited to:

- a) Note the information contained in the paper. and
- b) Consider and approve the AFI Plan work Programme and budget for the remaining period of 2023 and 2024.

#### 1. INTRODUCTION

1.1 This paper presents the proposed work programme and budget under the AFI Plan for the remaining period of 2023 and 2024. The programme was developed considering the status of implementation of the work programme approved by the 25<sup>th</sup> SC meeting in May 2022 and the initiatives and targets set for 2023 - 24 in the Programme Document of the AFI Plan for 2021 - 2024, as well as the decision and recommendations of the 25<sup>th</sup> AFI Plan Steering Committee meeting.

#### 2. SUMMARY OF PROGRESS MADE IN 2022

2.1 During its 25<sup>th</sup> meeting held from 17 to 18 May 2022; the Steering Committee reviewed the progress made in the implementation of the programme of activities that have been conducted under the AFI Plan for the year 2021/22. Since then, further progress has been made as discussed under Agenda Item 1 with the deferment of some activities to 2023.

### 3. SUMMARY OF 2023-24 WORK PROGRAMME

3.1 The formulation of the 2023-24 AFI Plan work programme considers the key objectives and targets set in the updated AFI Plan programme for 2021-2024. In this context it considers the progress made in achieving the annual targets set relating to the removal of all Significant Safety Concerns (SSCs), increase of EIs, certification of international aerodromes

and implementation of various projects designed under the AFI Plan. The details of the activities, the associated budget, and the specific targets to be achieved by the end of 2023-24 under each focus area, including the available funds from unearmarked contributions, are provided as Attachment A to this Discussion Paper.

- The status of the AFI Plan fund balance from unearmarked contributions on 20 July 2023 is 577, 098.00 CAD. The required budget to cover the various activities including the projects for the remaining year of 2023 and 2024 is about 309 215.00 USD and 993 330.00 USD respectively as presented in the Attachment A. It is important to mention that due to lack of some State's readiness to implement activities and other implementation constraints, the budget utilization since COVID-19 has been low. However, based on the implementation of the recommendations of the OIO evaluation, it is planned to improve the planning and implementation level significantly hence the level of budget requested for the year 2024.
- 3.3 In terms of assistance to States, efforts towards enhancing the capacity of safety oversight in the region are to be maintained with continued remote and onsite support by the Regional Office Safety Teams (ROSTs). In this regard, the AFI Plan Fundamental Safety Oversight (FSO) project implementation would play a key role. Assistance delivery by AFI-CIS, TCB Projects, COSCAPs/RSOOs and other partner programmes will also be conducted within the framework of the specific ICAO plans of action formulated for a particular State, coordinated through the AFI Plan and annual ICAO Regional Offices, AFCAC, RSOOs, RECs and other partners planning meeting.
- 3.4 In accordance with the 2017 Ezulwini Ministerial Declaration on Regional Safety Oversight Organizations (RSOO) in Africa and subsequent guidance provided by the SC of the AFI Plan on the development of a Strategic Plan for supporting and strengthening Regional Safety Oversight Organizations (RSOOs) in Africa, a study was conducted and presented to the 25<sup>th</sup> AFI Plan SC. Based on the recommendations of the SC, the study was submitted to Ministers responsible for civil aviation, RECs and other Stakeholders for consideration. Furthermore, in coordination with EU-EASA a high-level meeting scheduled in October 2023 during the Global RSOO forum to secure continental support and discuss the way forward in implementing the Declaration and strategies of the RSOO including conducting a follow up feasibility study.
- Considering the various initiatives and plans in the region aimed at developing and building capacity of aviation professionals, it was imperative that priority be given to the development of a comprehensive data base on aviation professionals related to ICAO Strategic Objectives, as well as to develop a gap analysis and a forecast of the needs of the aviation sector in Africa. Accordingly, a project was initiated, and a consultant engaged to conduct a study on enhancement of aviation professionals in the AFI region with an objective of developing sustainable professional personnel to carry out effective regulatory and oversight responsibilities in each area of the ICAO Strategic Objectives. The first phase of the study covered aviation safety and air navigation capacity was presented to States and stakeholders/partners at a validation workshop from 14 to 15 June 2023. The outcomes of the study will be provided to this meeting for consideration and further guidance. It is planned implementing priority trainings identified in the study during the year 2024.
- 3.6 In accordance with the 25<sup>th</sup> AFI Plan SC meeting decision related to supporting the Association of the African Aviation Training Organization (AATO), the AFI Plan Secretariat has continued to support the Association. Accordingly, ICAO participated at the 3<sup>rd</sup> AATO general

assembly and provided information on the guidance outlined and support for the sustainability of the organization. The proposed suggestions are currently under consideration and consultation between AATO and AFCAC has been progressing. AATO will provide update on the status of implementation to this meeting for further guidance.

- 3.7 The implementation of the AFI Plan projects on Aerodrome certification, State Safety Programme (SSP) establishment, Air Navigation Service Providers (ANSPs) Peer Review Programme, the Fundamentals of Safety Oversight (FSO) and Aeronautical Information Management (AIM) has been going on. The implementation programme activities and budget in the remaining period of the year 2023 and 2024 presented in attachment A.
- ICAO Assembly adopted a Resolution A41-27 (Appendix C-Airports and air navigation services economics, Section II. Aviation infrastructure management and financing), requesting the Council to continue to conduct and support relevant follow up work to implement the IWAF/3 Declaration and Framework for a Plan of Action for Development of Aviation Infrastructure in Africa under existing arrangements, within the framework of the ICAO AFI Plan. Subsequently, the AFI Plan SC decided to conduct the aviation infrastructure gap analysis in Africa in collaboration with the African Union Commission, African Civil Aviation Commission, Regional Economic Communities, and other relevant Organizations. Accordingly, technical working Group (TWG) coordinated by AUC /AFCAC that includes ICAO, States and industry constituted. The first technical working group meeting held in Morocco, Casablanca from 27-30 June 2023. During this meeting a coordinated strategy and project document prepared to conduct the study in a period of one year. ICAO assigned to carryout key activities such as designing the questionnaire, analysing the data/information, and drafting the study report.
- 3.9 The AFI Plan, as part of its activities of 2023-24, will also continue to serve as a coordination platform for the programmes, projects and initiatives of partners.
