2. ESTIMATE OF NATIONAL LEVEL OF IMPLEMENTATION

In Cape Verde over than 88% of all pilots and 98% of all air traffic controllers were tested to assess their level of proficiency in the English language used in radiotelephony communications.

The services of a foreign provider were contracted to assess language proficiency in accordance with ICAO recommended criteria.

Approximately 42 % of all pilots have demonstrated language proficiency at level 4 and above. Approximately 88 % of all air traffic controllers have demonstrated language proficiency at level 4 and above.

Detailed information on the level of implementation is found in Table 2.

3. LANGUAGE PROFICIENCY TRAINING PROGRAMMES

A national Steering Committee, involving the CAA and the aviation industry, headed by a Coordinator (the focal point) was established in 2006 to develop and implement a national plan of action, following ICAO guidelines.

A training program was established in 2007 by the air navigation service provider, which provided for language training and testing of all air traffic controllers in an English speaking country. As a result, the large majority of controllers have attained the specified ICAO standards in language proficiency. Selected personnel are undergoing additional specialised training to qualify as aviation English instructors for the internal training program.

A training program aiming at ensuring that national pilots maintain and exceed ICAO operational level 4 in language proficiency is being implemented by local airlines.

With the assistance of a foreign Authority, aviation English language instructors from educational institutions, airlines and air navigation service provider were trained to deliver specific aviation English training. Training and testing materials were also obtained and are being customized to develop an accredited national testing system. Cabo Verde has now built the capacity to conduct placement tests and deliver specific aviation English language training to the personnel affected.

Training capability using CAA provided training material has been established in partnership with a private organisation to assist the aviation community to meet industry training needs.

4. LANGUAGE PROFICIENCY ASSESSMENT (OR TESTING) FOR LICENSING PURPOSES

Under an existing technical assistance program Cabo Verde has obtained from a foreign CAA a complete English language testing package, which is being adapted by local experts to build a national testing system. This testing system is intended to be used in the future when it is sufficiently consolidated and properly validated.

Today, placements tests can be conducted by a local private organisation, under a specific agreement with the CAA, using standardized testing material.

Cabo Verde has contracted the services of an international services provider, who conducted aviation English tests for local pilots and air traffic controllers. The results of these tests were used for licence endorsement.

Additional testing for an updated assessment of level of compliance is anticipated for the third quarter of 2009.

Full compliance with required language proficiency requirements is anticipated for March 2011.
