The total number of the Pilots operating international flights, is 558. Pilots with ATPL - 496 and 62 pilot with CPL. Total number of pilots, satisfying the ICAO Language Proficiency Requirements, used for Radiotelephony communications is 522 (93.5%, respectively).

The total number of the Air Traffic Controllers, providing international flights is 529, including 267 TMA controllers and 262 ACC controllers. The total number of the Air Traffic Controllers, satisfying the ICAO Language Proficiency Requirements, used for Radiotelephony communications is 505 (95.5% respectively).

In December 2012, it is planned to fully implement the ICAO Language Proficiency Requirements, used for Radiotelephony communications.

# 3. Language proficiency assessment (or testing) for licensing purposes

- **3.1.** Training of Pilots and Controllers is caring out in specialized national and foreign aviation Training Centers in accordance with the programme approved by Civil Aviation Committee of the Republic of Kazakhstan.
- **3.2.** Certification of Pilots and Controllers shall be made with use of the certified training and testing programs.

The testing bodes for language proficiency assessment, adopted by the Civil Aviation Committee of the Republic of Kazakhstan:

- The Test of Professional Training Center of the RSE Kazaeronavigatsia (Kazakhstan, Almaty);
- Test TELLCAP®, CompLang Aviation Training Center (Russian Federation, Moscow);

• The test of Training Center ATOT (Kazakhstan, Atyrau).

The testing systems, approved by the Civil Aviation Committee and with a high degree of reliability, determine the level of General and aviation English members of the Flight crew, Air Traffic Controllers and are in accordance with the conditions and requirements of linguistics, testologii and aviation English language set forth in Chapter 6 of ICAO Doc. 9835.

Test Pilots and Air Traffic Controllers issued the appropriate certificates. On the basis of the certificates the endorsement on language proficiency put to the personnel license.

- 3.3. English language proficiency record in License includes the following data:
- Information on approval to conduct radiotelephony communication in the English language;
- English language proficiency validity (Level 6 has no validity date);
- Certificate reference number;
- Certificate issue date;
- ICAO English language Level уровень (number and level name: 6 (expert); 5 (extended); 4 (operational); 3 (pre-operational); 2 (elementary); 1 (pre-elementary)). ## 5. Interim measures to mitigate the risk

The basic measures for risk mitigation within the transition period are as follows:

- ensuring complete staff of flight crews and control centers operating international flights;
- maximum use of standard radiotelephony phraseology between pilots and air traffic controllers;
- using the most trained pilots conducting flights to high-density international airports;
- using of air traffic controllers with higher level of English language proficiency in the most overloaded sectors;
- monitoring the quality of conducting radiotelephony and taking timely measures for its improvement, if necessary;
- supervision of the specialists training process by the aviation administration, aircraft operators and air navigation services providers;
- improvement of training and testing methods for pilots and air traffic controllers;
- limiting employment of new specialists having English language proficiency level lower than the level established by requirements.
