

## Closing remarks by the Secretary General of ICAO, Mr. Juan Carlos Salazar, to the Programme for Directors General of Civil Aviation on compliance with ICAO Standards and Recommended Practices, Aviation Resilience, and Technical Cooperation Activities

(Punta Cana, Dominican Republic, 18 August 2022)

- I wish to reiterate, on behalf of ICAO and everyone who has taken part in this programme this week, our heartfelt gratitude to our Dominican Republic colleagues at IDAC for the excellent facilities we've been provided with, the unforgettable activities arranged for both delegates' and their companions, and most of all for the excellent attention and courtesy which has been demonstrated to each and everyone of us.

- 7. As you may be aware, ICAO's training activities are implemented through the Technical Cooperation Bureau which acts as the Organization's implementation support pillar.
- 8. TCB, in coordination with Regional Offices and technical bureaus, is continuously developing new implementation support products and services for States which are needs-based and results-oriented, to support your capacity building activities.
- 9. I invite you to contact TCB to explore opportunities to work with ICAO on your short and longer term aviation projects.
- 10. Before concluding today, I'd also like to encourage your States to take advantage of the ICAO ACT-SAF programme for sustainable aviation fuels, which provides tailored support to help States develop their full potential in SAF development and deployment.
- 11. I would also wish to appreciate once again the many participants who have helped to enrich this programme with their energy, insights, and enthusiasm.
- 12. ICAO is deeply grateful for your commitment and participation here, and I look forward to meeting you all again in Montréal in a few weeks' time.
