STATUS OF ACCESSION TO THE SADIS AGREEMENT

(Presented by the Secretariat)

1. Introduction

- 1.1 ICAO has received a formal notification of accession to the SADIS Agreement from 44 States (List in **Appendix 1**).
- 1.2 Eleven States have informed ICAO of their intention to accede to the SADIS Agreement but have not yet sent a formal notification of accession (List in **Appendix 2**).
- 1.3 38 other States receiving the SADIS service have not yet notified their intention to accede to the SADIS Agreement (List in **Appendix 3**). It should be noted that 19 of these States are Least Developed Countries (LDCs), which are exempted from payment of SADIS cost share.

2. Action by the Group

- 2.1 The SCRAG Group is invited to note the information presented in paragraph 1 above and in Appendices 1 to 3.
