1.2 **Registration**

2. HOTELS

3. VISA

3.1 All persons arriving in Trinidad and Tobago should have a valid passport and require visas to enter Trinidad and Tobago. However, because of historical ties and bilateral agreements, citizens of several countries are not required to have visas for entry. Participants are therefore advised to ascertain whether or not they are exempt from the Trinidadian entry visa requirement. 4. TRANSPORT

- 4.1 Although we would very much wish to welcome you at Piarco International Airport, Trinidad, it will not be possible to meet participants on arrival and provide transportation due to staffing limitations. Customs

- 6.1 The following items may be brought into Trinidad duty free:
 - Personal effects, such as necessary clothing
 - 200 cigarettes, or 250 gr. of cigars or tobacco
 - 2 bottles of 750 ml alcoholic beverages
 - Perfume for personal use

Additional quantities of the above items may also be purchased from the Piarco International Airport Duty Free Shops after clearing customs.

Airport Departure Tax

A Departure Tax of TT\$100.00 must be paid by everyone when leaving the country.

Clothing

6.3 Our islands have two main seasons – the Dry Season, from January to May and the Wet or Rainy Season, from June to December. Our islands share an average daytime temperature of 28° that is warm but not unpleasantly humid and nights that are pleasantly cool.

7. CURRENCY, CREDIT CARDS AND BANKING SERVICES

- 7.1 The unit of currency in Trinidad and Tobago is the TT Dollar (TTD), which is in denominations of 100, 20, 10, 5 and 1. Current rate of exchange for US\$ is US\$1 = TT\$6.30 approximately.
- 7.2 There are no restrictions on import of foreign currency.
- 7.3 Both travellers' cheques and international credit cards are readily accepted, in addition to US cash. Most Automatic Teller Machines (ATMs) will accept your cards as well.
- 7.4 All commercial banks exchange major foreign currencies and are open 8:00 a.m. -2:00 p.m., Monday to Thursday. On Fridays, banks open from 8:00 a.m. until noon, then resume at 3:00 p.m. until 5:00 p.m.
- 7.5 Banks located in the malls and shopping plazas are the exception to this rule they open from 10:00 a.m. until 6:00 p.m. with no closing time in between 0830 -1330 hours Sundays through Thursdays.

8. OTHER USEFUL INFORMATION

Shopping

8.1 Be prepared to bargain in small shops, sidewalk vendors etc. Some prices are fixed to certain items.

Tap Water

8.2 Tap water is generally safe for consumption. However, it is recommended that all visitors drink bottled water/beverages.

Telephone Cards

8.3 Cards are available at the Hotel for international calls.
